As a result of this, in certain cases CIDA will have to reconsider some of its financial commitments with respect to foreign countries, either over a somewhat longer period of years or by decreasing certain contributions in some cases. CIDA is now actively engaged in that reconsideration and the details are not available to me. However, I am advised by the Secretary of State for External Affairs (Mr. MacEachen) that he would see to it that the information is available as soon as he gets it.
