And also,—Copy of agreement dated 19th August, 1931, entered into with the Government of British Columbia concerning the same.

Mr. Rhodes, a Member of the King's Privy Council, delivered a Message from His Excellency the Governor General which was read by the Speaker, as follows:—

BESSBOROUGH.

The Governor General transmits to the House of Commons Estimates of sums required for the service of the Dominion for the year ending on the 31st March, 1933, and, in accordance with the provisions of "The British North America Act, 1867," the Governor General recommends these Estimates to the House of Commons.
