

PAPAL MEDAL TO E. J. HENNEBERRY

Received by K. C. State Deputy—His Fine Speech at Anniversary.

E. J. Henneberry, of St. John, State Deputy, Knights of Columbus, has received one of the Papal Medals struck by Pope Pius XI to mark the services of the Knights of Columbus in erecting the Oratory of St. Peter in Rome.

The medal, which is of bronze, bears on the obverse side a likeness of His Holiness and on the reverse the facade of the Oratory of St. Peter with the great dome of St. Peter's in the background.

The English translation of the inscription on the reverse side is: "To fulfill the best wishes of our Holy Father, Pius XI, the Knights of Columbus, at their own expense founded this Oratory of St. Peter, for the Christian development of the Roman Youth."

Fine Address at Banquet.

Mr. Henneberry, who is filling the important office of state deputy with marked success, has been an active member of the Knights of Columbus for some years and is very popular among its associates of St. John. He was the guest of honor at the anniversary banquet held at the Oratory of St. Peter, which was held on Monday night.

Among his other qualifications, his gift of oratory is widely recognized and it is the more noticeable, therefore, that in the Times-Star report of the anniversary banquet speeches yesterday, there was no mention of Mr. Henneberry's address in reply to the toast to the Columbian Order. It was one of those regrettable things that will happen sometimes in the whirl of a busy day in a newspaper office.

In his speech, Mr. Henneberry brought forth a host of facts and figures, in contrast, he held his auditors keyed up to the closest attention as he dealt with his subject in eloquent terms. A little later, when Mayor Potts rose to speak to the toast of the City of St. John, Mr. Henneberry took occasion to compliment Mr. Henneberry on his gift of oratory and on the mastery with which he had spoken in response to the toast of "Our Order."

E. Nash, expert accountant for the liquidators. On May 18, 1922, a few days prior to the annual statement of the bank, the original statement of the bank had been repaid a few days after the completion of the report a new loan was placed. I. P. Meeting in Mechanics' Institute in November, 1894, is Recalled.

The Local Council of Women of St. John was organized 30 years ago this month and is able to look back upon a history of much achievement. Organized with about a dozen societies affiliated, it now has about 80 and is one of the most influential bodies in the city. The help of the Council can always be secured for any worthy object and they have put over many excellent campaigns.

One of the achievements of the Council is the establishment of the Free Milk Fund, which has supplied milk for babies who might otherwise have been forced to go without and they have no doubt helped to save infant lives through this supply of milk.

The organization took place on Nov. 8, 1894, in the Mechanics' Institute, and The Telegraph of Nov. 9, reporting the meeting, says that nearly a dozen societies were represented.
