

10. *Resolved*, That a sum not exceeding Twenty-eight thousand three hundred and fifty dollars be granted to Her Majesty, to defray the following expenses in connection with Public Buildings, *Quebec*, viz.: *Montreal Custom House*, \$600; *Chicoutimi Marine Hospital*—Additional amount required for ice house, stable and shed, \$900; *St. Vincent de Paul Penitentiary*—Additional amount required, \$14,200; *Queen's Wharf Buildings*, \$600; *Quebec Dominion Buildings*—Improvements, &c.
