

LANDS, DOMINION:—Bill to amend the Dominion Lands Act (Sir J. A. Macdonald); Ordered; Presented, 248. Read second time; Committed; Amended; Considered, 309. Motion for third reading; Amendments moved to re-commit the Bill: 1. By Mr. Mills, for purpose of limiting area of land to be sold to one person; Negatived; 2. By Mr. Charlton, to provide that all lands shall be disposed of subject to conditions of actual settlement; Negatived; 3. By Mr. Holton, to provide that unappropriated even-numbered sections in each Township shall only be disposed of upon condition of actual settlement, 320. Negatived; 4. By Mr. Blake, to provide that the price of Dominion lands sold without conditions of actual settlement shall be payable in cash at time of sale; Negatived; Bill read third time and passed, 321. By the Senate, with an amendment; Considered; Agreed to, 372. R.A., 390. (44 Vic., c. 16.)
