HAMILTON, July 3.—The first race to-day was the 2300 class, in which five heats were trotted yesterday. Jupiter Jr. winning two heats, Eglantine two and Carillon one. D. T. Hughes' horse Eglantine was looked upon as a likely winner in the concluding heat, but his driver was unable to hold him, and after making several attempts he was taken back to the stable.

Only Jupiter and Carillon started in the heat, and Jupiter Jr. went away from the Hamilton entry from the start, winning easily in the slow time of 2:30. Eglantine was given third money and Fasti fourth, although neither started. The 2:27 class trotters had eight starters, but Bryson and Brooke were drawn after the fourth heat. Ballower won the first heat with ease, but in the second was pushed by C. J. Hamlin's Robert J., 2:05, who sent an exhibition mile against time with Driver Ed Geers and a runner keeping company. Although the pacer did not lower his own record he succeeded in breaking the record of several others. The fastest trotting record for Canada was 2:13 and the fastest pacing record was 2:13. The time made by Robert J. in 2:07. The time by quarters was as follows: Quarter 32.14, half 1:03.12, three-quarters 1:54, mile 2:47.

The noted trotter Fantasy, owned by Mr. Hamlin, also went a mile against time accompanied by runner mate. THE U.S. TARIFF BILL PASSED

THE SENATE CARRIES IT BY A MAJORITY OF FIVE.

A Long Discussion on the Wool Schedule, and Wool Remains Free—Coal Remains on the Doubtful List—The President and Judges Must Pay Income Tax.

WASHINGTON, July 3.—The second day's action on the amendments of the Committee of the Whole to the Tariff bill occupied the whole of today's session of the Senate. The amendments were placed on the free list. The duties on collars and cuffs were fixed at 30 cents per dozen and 30 cent ad valorem.

Then the great wool schedule came up for action. Mr. Sherman (Rep., Ohio) offering an amendment to place wool on dutiable list at 30 cent ad valorem. Despite passionate appeals there was no change in the wool schedule.

The committee amendment placing bituminous coal on the dutiable list at 40c a ton and coal slack at 15c was agreed to by a vote of 57 to 6.

The committee amendment, which had been originally offered by Mr. Hill (Dem., N.Y.), exempting the salaries of the President of the United States and of the judges of the United States from the income tax, was rejected after a brief struggle by a vote of 34, yeas 26, 10 Democrats having voted for it and 26 Republicans and 3 Progressives against it.

The bill for the purpose of further postponement if necessary, Barbed wire was a vote of 35 to 14. A resolution was agreed to in committee of the whole that barred wire for fencing should be admitted free of duty. This amendment was rejected.
