CANADA FORESTRY ACT

REFERENCE TO REPORT IN HAMILTON "SPECTATOR" OF DECEMBER 2

Hon. Colin Gibson (Minister of Mines and Resources): Mr. Speaker, I rise on a question of privilege. I wish to bring to the attention of the house a Canadian Press dispatch dated the 1st of December, published in the Hamilton Spectator on Friday, December 2, with reference to the Canada Forestry Act. SYDNEY H. PAWLOWSKI NAMED WORLD OATS KING AT CHICAGO GRAIN AND HAY SHOW

CUSTOMS TARIFF

AMENDMENT WITH RESPECT TO USED OR SECOND-HAND MOTOR VEHICLES AND AIRCRAFT

Hon. Douglas Abbott (Minister of Finance) moved for leave to introduce Bill No. 221, to amend the Customs Tariff.

He said: Mr. Speaker, although this bill stands in my name, it is being presented at the suggestion of my colleague the Minister of National Revenue (Mr. McCann). Its principal purpose is to permit secondhand motor vehicles to be admitted into Canada in exceptional cases. Instances of hardship have arisen affecting immigrants and others who enter Canada and are not able to bring their cars into the country. The department is anxious to be given authority to admit such cars in special cases.
