is not the United States. What might make sense in the United States, a country with a population 10 or 11 times the size of ours, does not make sense in this country. I am not one who sees a bogeyman in United States investment. I do not believe that United States investment cannot be controlled or directed to the best purposes of this nation, if we want it that way. The danger is not so much from the investment or the fact that they are Americans, Germans or anyone else, but from the fact that they bring with them their pattern of doing business which is inappropriate to our society. It just does not make sense. We have one of two choices. Either we break through this pattern and find some way of developing different methods of production in this country, or we succumb to that great continental market.

Continental integration of our economy would be a disaster of the greatest magnitude for us. Continental integration does not give you a political say. However, I do not want to discuss that aspect of the political problem. I would rather go on with the technical details. I would like the opportunity of going further into this matter with the minister. I want to conclude my remarks because it is getting rather late in the evening. I would like to make a few more remarks at this time and perhaps avail myself of the opportunity of making some additional comments later on.
