Mr. Munro: Mr. Speaker, I rise on a point of order this time. Previously I raised a question of privilege, which apparently had no effect because the hon. member kept on with the same thing. But as a point of order, Mr. Speaker, what possible relevance has that man visiting my office got to the motion before us today? Does the hon. member have anything constructive to contribute toward how we can better present our programs in the old age pension field or not?

Mr. Deputy Speaker: Order. I think my position on this matter has been stated twice, and has been very clear. I invited the cooperation of the hon. member on this matter. I have expressed my grave misgivings about this line of debate on this motion. I know the hon, member is probably much more experienced in the rules than I am, and he knows the reasons that I have expressed this point of view. The house resumed consideration of the motion of Mr. Knowles (Winnipeg North Centre).

Mr. Lloyd Francis (Ottawa West): Mr. Speaker, in this house we have had a number of motions quite similar to the one which is before us. As recently as Friday last a major debate took place on the Public Service Superannuation Act and a number of hon. members, myself included, expressed our views on what should be done to assist in the difficulties in which superannuated civil servants find themselves. The matter raised by the mover of this motion has frequently been debated on the late show and on other resolutions of his, and I must give him full credit for being absolutely persistent.

The business of the government of this country is not only to be concerned with aspects of social welfare and generally the distribution of the benefits of our affluent society, but also to be concerned with the broader problems of its responsibilities in other fields and priorities. This afternoon the Minister of National Health and Welfare (Mr. Munro) outlined what has been done. Hon. members on the other side, particularly in the party of the mover of the motion, referred to the 1919 resolution of the Liberal party. They usually do so with a little derision in their

minds.
