EMERGENCY PLANNING CANADA

Mr. John Bosley (Parliamentary Secretary to Prime Minister):

There is a government organization known as Emergency Planning Canada, which is tasked by the emergency planning secretariat in the Privy Council office for the co-ordination of emergency planning among federal departments and agencies; and between them and the provincial governments.

Emergency Planning Canada's budget is carried in the estimates of the Department of National Defence and, for the current fiscal year, includes approximately \$1.4 million for salaries and \$4,921,000 for operating expenses. Out of the

latter, \$3,827,000 was identified for the provision of assistance to provinces and territories in their emergency planning. However, since \$2 million of this was budgetted for a change in program which did not take place, that amount has been frozen, leaving \$1,827,000 available to provinces as under:
