INCOME TAX ACT

MEASURE TO AMEND

Mr. Rod Laporte (Moose Jaw—Lake Centre) moved that Bill C-300, an act to amend the Income Tax Act (tuition credit and education credit), be read the second time and referred to Legislative Committee E.

He said: Mr. Speaker, I am pleased to be able to rise to speak to this bill today.

There are two fundamental areas where no one is going to dispute that government should be involved: health and education. This bill deals specifically with education.

The purpose of this bill is to provide a tax deduction for Canadians who incur costs for educational programs, tutors and so on; programs that are required but are not available through any public educational facility.

There has been a lot of concern and a lot of attention placed toward the education of Canadians, particularly in the last few years. We have heard that 30 per cent of high school students do not finish high school. The government, to its credit, has started a stay in school initiative which is to be commended. We still have a lot of students not finishing school because of social or cultural factors. They may be from broken homes, they may be drug or alcohol abusers or they may just choose to leave.
