

4. During the same period, what contracts for standardization, rebuilding or construction were awarded without tender by the provincial governments to supervisors who were remunerated on a commission basis on the cost of labour materials?

5. What are the names, occupations and domiciles of the supervisors referred to in the preceding question?

*Mr. Boulanger**—On Monday next—ADDRESS—For a copy of all correspondence between the Prime Minister of Canada and the several provincial ministers bearing on the proposal to amend the British North America Act to create a federal system of insurance against unemployment.

*Mr. Lennard**—On Monday next—ORDER OF THE HOUSE—For a copy of all papers, letters, telegrams, specifications and other documents in the possession of the Government with respect to reconstruction of South Pier, Burlington Channel, during the years 1936 and 1937.

*Mr. Church**—On Monday next—ADDRESS—For a copy of all correspondence, Orders in Council, letters, telegrams and other documents exchanged between the Government of Canada or any official thereof and any other persons, relating to the sale of Anticosti Island, or any part thereof, or of its natural resources.

Mr. McIntosh—On Monday next—The following proposed Resolution:—That, in the opinion of this House, a Special Select Committee be appointed for the purpose of considering the advisability of adopting a distinctive Canadian flag, representing Canada as a whole, thereby symbolizing the Dominion as an equality partner in the Commonwealth of British nations.

Mr. Ross (Moose Jaw)—On Monday next—The following proposed Resolution:—That a special committee, the members thereof to be selected at a later date, be appointed to investigate:—

- (a) The application of the Customs Tariff by the officers and clerks of the Department of National Revenue;
- (b) The collection of Customs duties;
- (c) The practice now followed in applying the present law respecting drawbacks;

And that the said special committee have power to send for persons, papers and records, to examine witnesses under oath, and to report from time to time.

Mr. Coldwell—On Monday next—The following proposed Resolution:—That, in the opinion of this House, the Government should place before Parliament at an early date plans, or proposals, for a comprehensive and authoritative survey of water conservation, irrigation possibilities, and other feasible projects for the permanent rehabilitation of the drought stricken area of Western Canada and its people.

Mr. Reid—On Monday next—The following proposed Resolution:—Whereas a Commission was appointed in 1922 to examine and report on all matters connected with the fishing industry of British Columbia;

And whereas amongst other findings they recommended that steps be taken to eliminate the Japanese fishermen so as to safeguard the fishing industry for white Canadian fishermen;

And whereas steps were taken in 1923 by the Dominion Government to implement this recommendation by the reduction of fishing licences issued annually to Japanese fishermen.
