GENEVA, Feb. 10.—Summoned home to Vienna on account of his mother's illness, a penniless young Austrian named Lutz set out from Zurich, 300 miles away, on foot.

REFORMS IN GERMAN NAVY

Training of Officers and Seamen on Sailing Ships Abolished.

BERLIN, Feb. 10.—The German ministry of Marine has decided to introduce an important change in the system of training naval cadets and blue-jackets.

The practical training of future officers and seamen of the German fleet will not take place on sailing vessels, but on modern, unrigged cruisers.

The decision entirely to abolish training aboard sailing ships is due to the conviction of German naval experts that the time spent in handling the sails of a large vessel is far better employed in teaching future officers and seamen gunnery, and enabling them to obtain a thorough acquaintance with the intricate mechanism and organization of a modern warship.

Henceforth both naval cadets and blue-jackets will receive sailing lessons only in ships' boats.

Opinion in German naval circles is unanimously in favor of the complete abolition of out-fashioned training ships.

McARTHUR THERE WITH HIS MODEL

FREDERICTON, Feb. 10.—In the case of McArthur and McVey v. the city of St. John, now being tried here before Judge White and jury, William A. McVey continued his testimony today. He gave detailed information in regard to rock cutting, and exhibited numerous photographs and profiles of work. There were numerous questions asked, and the evidence in the proceedings. At 4.20, before his cross-examination had begun, McVey was stood aside and John Harrison, who worked on the water works survey, was called and testified in regard to the location of test pits.

McArthur Called

George McArthur was next called and brought into court a wooden box-like apparatus which he explained was a model of the form used in the trench for holding the reinforced concrete aqueduct.

Skinner and Peel objected to the exhibit, but Powell contended that it was necessary in order to give the jury a general idea of the nature of the work which had to be perfected in the trench. He contended that the five-foot trench called for by specifications was not wide enough to enable the concrete work to be properly done, and the contractors were compelled to widen the excavations. McArthur's evidence in explanation of the model was admissible and McArthur swore that it was an exact reproduction of the form used in preparing concrete for the aqueduct.

His honor urged the counsel to get through with the unsightly model as quick as possible, that it might be removed from the court room.
