2. How many buildings are involved?

3. On what basis did the Department estimate the value of work done?

Hon. Léo Cadieux (Minister of National Defence): Mr. Speaker, the answer to this question is in three parts. 1. A contract was awarded to Acme Window Cleaners, Kingston, Ontario, for window cleaning at the Canadian Forces Base, Kingston, Ontario, in the amount of \$18,430. Payment is based on spring cleaning at \$9,065 for work to be completed by approximately June 27, 1969, and fall cleaning at \$9,365 for work to be completed by October 31, 1969. The base establishment does not provide military or civilian staff to carry out services of this nature. In addition, it is considered more economical to carry out this type of work at urban locations by contract rather than by casual labour.

- 2. 128 buildings were involved.
- 3. The contract was placed on the basis of the lower competitive tender received for performance of the work. The estimated cost was based on size, height and number of windows.

QUEBEC-CANADIAN FORCES TRADE SCHOOL

Question No. 2,478-Mr. Robinson:

Is it the federal government's intention to establish a French-speaking trade school in Quebec for Canadian Forces and, if so, what is the cost, how many tradesmen will be trained per month and how will they be absorbed into the Canadian Forces?

Mr. D. W. Groos (Parliamentary Secretary to the Minister of National Defence): L'École Technique des Forces canadiennes was opened at Saint-Jean, Quebec, on April 15, 1969. In view of the fact that only one course has commenced, an estimate of the costs involved, and the number to be trained per month is not yet available. On completion of training, these tradesmen will be absorbed into French-speaking units of the Canadian Forces. This will not preclude them, however, from future employment with English-speaking units.
