I could see from my seat that the Prime Minister was reading from a directive as opposed to any other document. I could see the paper from this distance of two sword lengths from the Prime Minister in this place in which I sit. I ask Your Honour to require the Prime Minister to table the directives and the guidelines to his ministers so that we in the House of Commons may see under what restraints and constrictions members of cabinet operate.

Madam Speaker: The hon. member is correct in quoting that particular reference from Beauchesne's. It is not clear to me—and I will check *Hansard*—whether the Prime Minister (Mr. Trudeau) was quoting from an official document or from *Hansard*, as I believe was the hon. member for Durham-Northumberland (Mr. Lawrence). We will check *Hansard*; the point of the hon. member is well taken.
