NICKLE REFUSES OFFER TO **BECOME ATTORNEY-GENERAL**

Endorses Drury Government, but Private Affairs Prevent His Accepting Office.

GIVE NEW GOVERNMENT AMPLE OPPORTUNITY

TORONTO, Nov. 13.—Mr. W. F. Nickle has refused the position of At-torney-General which was offered to him last night by Premier Drury. The reasons that influenced him in his decision are entirely connected with his private affairs. He further said: "I think that I Mr. Nickle stated that he had noth-Mr. Nickle stated that he had noth-ing but sympathy and good wishes for Mr. Drury. "His presence is very pre-possessing. He is self-evidently shonest, genial and free." He emphasized that his own refusal was purely in connection with personal 1 affairs, not because he feared that the new government would have a transient career. The same reasons that pre-by vented his continuing in the federal a rena were operative still.

He further said: "I think that I should say that I've been impressed with the desire of Mr. Drury to pro-mote efficiency and economy and to at large. I believe that there is a widespread desire that the new government should be given ample oppor-tunity to work out its policies, free from captious criticism or obstructive opposition. After that, it must be judged by its works."

NEW YORK STOCKS SHOW HEAVIEST **DECLINE IN YEARS**

General Motors Selling Last Week at 400 Drop to 280.

NEW YORK, Nov. 13.—Under pressure from the federal reserve board and other powerful financial interests. Wall Street has adopted more vigorous measures to put its house in order. This was accomplished by severe losses on a turnover of more than 2,500,000 shares, the year's record— and an advance in call loans to 30 per cent.—a rate unparalleled since the panic of 1907. In the course of the decline, specular

In the course of the decline, specula-tive favorities registered losses of 10 to 25 points, their minimum quotations being 30 to 60 points below maximums of the last fortnight. 


