MYSTERY SOLVED

Death of Mrs. Joseph Pulitzes Traced to Wm. Hooper Young.

New York Sept. 20.—The mystery of the murder of Mrs. Annie Pulitzer, whose nude body was found in the Morris canal, near Jersey City, has been cleared up by the discovery that the woman was killed in a flat at 103 west Fifty-eighth street, where her clothing was found last night.

Capt. Titus, of the detective bureau. alleges that the murder was committed by a man named William Hooper Young, grandson, of the famous Mormon leader, who has recently been employed in a cheap restaurant, and who formerly pub-lished the Hoboken Crusaden . His picture was shown to the Hoboken liveryman, who at once identified him as the unknown man who hired the buggy from him Wednesday night.

The house in which the murdered woman's clothes was found is a cheap tenement, in a block containing many stables, but is within a stone's throw of some of the most splendid apartment houses in the vicinity of Central Park South.

An autopsy performed on the body of Mrs. Pulitzer, showed that her death was caused primarily by a knife wound in the abdomen and not by chloral. Several blows were struck on her head before death, but the skull was not fractured, and there were no signs of cerebral hemorrhage.

A police dragnet has been thrown out for Young. Among the books found in his room in the Fifty-eighth street flat, was the cover of a small memorandum, on the front of which was stamped in gold letters "Practical reference." On the inside were a number of notes headed, "Blood atonement," and followed by biblical references, including an exerpt from the book of Corinthians reading:

"To deliver such an one unto Satan for the destruction of the flesh, that the spirit may be saved in the day of the Lord Jesus." Detectives have traced Young to

morning to bid a friend good-bye. To this friend he said he was going to the Rocky Mountains.

A trunk shipped to Chicago by Young, through the Wells-Fargo ex-Chicago by press, was consigned to "C. S. Eileny." The police do not believe it contained anything other than clothing belonging, possibly to Mrs. Pulitzer, as very little of the murdered woman's apparel has been found.

Richard E. Anzer, a close friend of Young, and at one time his partner in the publication of the Hoboken Crusader, says that Young called at his house in Hoboken last Thursday morning about 7.30 o'clock. Young, he says was driving a horse and buggy which he stated had been rented by the liveryman, who has since figured in the dentification of the weight found at-

tached to Mrs. Pulitzer's body. Anzer says he met Young at Butte, Mont, in 1901. Young was then traveling for a drug house, They became friends and Young, later in the year, joined him in the publication of the paper in Hoboken. They dissolved partnership last June, however, and since then had seldom met.

Salt Lake, Utah, Sept. 20.-Hooper Young, suspected by the police as the murderer of Mrs. Pulitzer, in New York, is the son of John W. Young ,a son of Brigham Young, and is a well known railroad contractor, having become wealthy from contracts in the construction of the Utah & Northern and Utah Central railways. At the time of Brigham Young's death in 1877, John A. Young was one of the former's councillors. He was tried under the Edmunds law, charged with polygamy, but was acquitted on a a technicality.

Hooper Young is well known in Salt Lake, having resided here up to a few years ago.

Outrages on the Increase.

Washington, D.C., Sept. 19.-Anoth er Poxer uprising is imminent in China which may equal in violence that of 1900. Mail advices received at the State Department from United States Minister Conger at Pekin, dated last month, show a serious condition of affairs, and the lives of all foreigners are deemed in danger. The trouble ap pears to arise principally from extor-tionate taxation, combined with resentment against the presence of missionaries, thus justifying the judgment of the Department of State, which pointed out to the powers that the demand for excessive indemnitie would result in serious internal trouble in China.


