"WILLFUL MURDER."

Such Is the Verdict at the Coroner's Inquest.

Charles Hodges Will Be Put on Trial for His Life.

The Jury Indite Him for the Slaying of Benjamin Hubbard on Sunday—The Farm Laborers' Testimony.

The inquest on the death of Benjamir The inquest on the death of Benjamin Hubbard was resumed by Coroner Flock at Fralick's Hotel, Arva, Thursday atternoon. Attorney McKillop appeared for the Crown, and Mr. J. Judd for the prisoner, Charles Hodges, who was present and quietly followed the evidence.

George Watt, a laborer employed on the Geary farm, was the first witness called. He testified that he saw the prisoner and deceased on the Sunday afternoon when the

He restified that he saw the prisoner and deceased on the Sunday afternoon when the tragedy occurred. Both men were at the milk house on a platform near the door, and were wrestling with each other. Hubbard had Hodges by the whisker, and Hodges had Hubbard by the collar. Mrs. Hodges hen ran up to them and parted them. Hodges then went into the milk house and Hubbard staggered down the steps like a drunken man and fell forward on his face. The witness thought Hubbard was intoxicated and did not go near him. He did not see Hubbard again until he was laid in the cated and did not go near nim. He did not see Hubbard again until he was laid in the barn. He was dead then and there was a dark stain over the left breast. Hodges went to the engine house shortly after and said, "I believe Hubbard is dead."

A close examination drew from the witness the fact that he had seen the prisoner half an hour after the tragedy.

The rest of the evidence was given very reluctantly, the witness maintaining that he did not remember what he said to the prisoner other than that he talked to him about taking his milk route the next day. He had not seen him with a knife that day, but he was in the habit of carrying a two-bladed tobacco knife. The men were not on good terms for some time on account of previous quarrels, and frequently they called each other names.

To Mr. J. Judd the witness stated that he never saw Hodges with a knife, except in his own house, as smoking was not allowed near the farm buildings.

Re-examined by Attorney McKillop the witness admitted that he charged Hodges with stabbing Hubbard, and that the prisoner said he did not stab him but that he had struck him.

Robert Geary, brother of the man who employed the deceased and the prisoner testified that fire was within sight of the milk house when the quarrel took place. Hodges then came over to the boiler-house and said: "Ben caught me by the whiskers and struck mo in the face. ALFRED WOODS' EVIDENCE.

He sat with Hodges for about fifteen minutes and then went to bed. He did not get up when the officers came for Hodges. He was employed by Hodges and slept in his house.
