BRITAIN AND VENEZUELA.

A LITTLE ADVICE TENDERED TO UNCLE SAM.

Letter John With John Bull in Teaching "These Spanish-Indian Barbarians" Lesson—Sensational Remarks Sent Out From Washington for Which There is No Foundation.

London, Oct. 21.—The St. James' Gazette in an article on the solution of the dispute between Great Britain and Venezuela, says: "The United States Government has serious grievances of its own against Venezuela, and it would be well for it to consider the possibility of bringing these Spanish-Indian barbarians to order. A good lesson given to Venezuela would be equally profitable to both the United States and England. The co-operation of the United States would also be humane, since it would have a tendency to make the lesson bloodless in convincing the Venezuelans of the folly of resistance. The Westminster Gazette says: Venezuela, like Nicaragua, after much fuss will probably prove to be small beer. No doubt the less scrupulous of the New York papers will talk big about what they are going to do with the lion's tail, but Great Britain and the United States are not going to be set by the ears by a pack of Venezuelans. The Globe says: Even if the Monroe doctrine was an axiom of international law, it could have no bearing upon our dispute with Venezuela. The most application can only be to insist that no European power shall erect a fresh lodgment in America. It does not alter the decision of England not to allow Venezuela to occupy part of the colony of British Guiana."

The Globe publishes an authorized note saying that as the British ultimatum to Venezuela has not yet reached its destination, it is not considered desirable to discuss any of its details. It is proper to state, however, that the document is worded in terms of fairness and force. The communication, the Globe says, was not transmitted through any representative of the British Government, but through diplomatic relations between the two countries. The note further says that the ultimatum informs the Government of Venezuela that the Government of Great Britain will not permit any overstepping by Venezuela of the boundaries marked by the course of the Cuyana and Urucura Rivers. Great Britain, however, expresses willingness to submit to arbitration the question of other territories in dispute beyond that limit.

The Pall Mall Gazette asserts that the ultimatum will be presented through the Legation of Venezuela in London.

The Shills That Would Take Part.—The Pall Mall Gazette says that should it be decided by the British Government to take naval action against Venezuela, the movement would be confined to Vice-Admiral James Elphinstone, in command of the North American and West Indian Squadron. The disposition of the vessels in his fleet at the time of his last communication with the Admiralty Department in Whitehall was as follows: Crescent at Halifax, Canada; at Barbadoes, Madeira, Puerto Rico and Havana; the Bermuda, Mohawk and Tourmaline at Jamaica, Partridge at the Bahamas, and the Cleopatra, Pelican and Buzzard in Newfoundland waters.

A French Opinion.—Paris, Oct. 21.—The Figaro, alluding to the Venezuelan dispute, expresses the opinion that the system of issuing stamps for sale arrested him. He had with him a number of stamps that had been cleaned.

At the Police Station he gave his proper address, but would say nothing as to how he came into possession of the stamps. Harrison and Ross visited the address given, and learned that Sadder was only a roomer in the building.

Caledonia, Oct. 21.—At 11 o'clock Saturday night, Park Pattison, a barber, was shaving a customer, when he suddenly remarked that it was too warm to work.

He put his razor in his pocket and went into his house behind the shop. He locked the door behind him, and the customers in the shop sat stupefied with wonder at Pattison's strange conduct.

The next they heard was a scream from the house, and they tried unsuccessfully to break in the door.

After a moment Mrs. Pattison unlocked the door and rushed out, with blood streaming from a gash on her throat.

"Save the children," she screamed, and hearing going quickly into the house, found Pattison trying to cut his own throat with the razor.

In the struggle, however, the razor had been broken, and Pattison was unable to cut his throat. Doctors were called, and he was taken to the lock-up, where he tried to beat out his brains on the stone wall.

He managed to cut his head, and 12 stitches were put in the wound.

Mrs. Pattison has a chance to recover, and Pattison may go insane. Jealousy was the cause.

The Globe says: Even if the Monroe doctrine was an axiom of international law, it could have no bearing upon our dispute with Venezuela. The most application can only be to insist that no European power shall erect a fresh lodgment in America. It does not alter the decision of England not to allow Venezuela to occupy part of the colony of British Guiana."

The Globe publishes an authorized note saying that as the British ultimatum to Venezuela has not yet reached its destination, it is not considered desirable to discuss any of its details. It is proper to state, however, that the document is worded in terms of fairness and force. The communication, the Globe says, was not transmitted through any representative of the British Government, but through diplomatic relations between the two countries. The note further says that the ultimatum informs the Government of Venezuela that the Government of Great Britain will not permit any overstepping by Venezuela of the boundaries marked by the course of the Cuyana and Urucura Rivers. Great Britain, however, expresses willingness to submit to arbitration the question of other territories in dispute beyond that limit.

The Pall Mall Gazette asserts that the ultimatum will be presented through the Legation of Venezuela in London.

The Shills That Would Take Part.—The Pall Mall Gazette says that should it be decided by the British Government to take naval action against Venezuela, the movement would be confined to Vice-Admiral James Elphinstone, in command of the North American and West Indian Squadron. The disposition of the vessels in his fleet at the time of his last communication with the Admiralty Department in Whitehall was as follows: Crescent at Halifax, Canada; at Barbadoes, Madeira, Puerto Rico and Havana; the Bermuda, Mohawk and Tourmaline at Jamaica, Partridge at the Bahamas, and the Cleopatra, Pelican and Buzzard in Newfoundland waters.

A French Opinion.—Paris, Oct. 21.—The Figaro, alluding to the Venezuelan dispute, expresses the opinion that the system of issuing stamps for sale arrested him. He had with him a number of stamps that had been cleaned.

At the Police Station he gave his proper address, but would say nothing as to how he came into possession of the stamps. Harrison and Ross visited the address given, and learned that Sadder was only a roomer in the building.
