Information

21 (1) Subject to subsection (2), the Information Commissioner may, authorize any person to exercise or perform subject to such restrictions or limitations as the Commission may specify, any of the powers, duties or functions of the Commissioner under the Act except the power to delegate...

(2) The Information Commissioner may not delegate the investigation of any complaint resulting from a refusal by the head of a government institution to disclose a record or a part thereof pursuant to paragraph 13(1) or section 12 except to one or a team of two officers or employees of the Commission specifically designated by the Commission for the purpose of conducting such investigations.

General

22 The principal office of the Information Commissioner shall be in the National Capital Region described in the schedule to the National Capital Act.

24 For the purpose of any investigation by the Information Commissioner under this Act or any other Act of Parliament, any information with respect to a person or an institution or persons that is obtained under or in the course of the administration of any Act of Parliament may, notwithstanding any privilege established under such Act or the report of the Commissioner or any person acting on behalf or under the direction of the Commissioner, be communicated to the Commissioner or such other person, and the Commissioner and any person acting on behalf or under the direction of the Commissioner is entitled to have access to any statement or other writing containing any such information.
