WHEAT-FREIGHT CAR DISTRIBUTION

Question No. 399-Mr. Diefenbaker:

1. Who is responsible for freight car distribution for the transport of wheat from line elevators?

2. On what basis are such cars distributed or allocated among marketing centres?

The Canadian wheat board, the railways, the grain elevator companies and the transport controller are jointly responsible to a varying degree for the distribution of box cars for the transport of grain from line elevators.

The grain elevator companies receive authority from the Canadian wheat board to ship grain either against specific shipping instructions issued by the board or against open shipping orders for specified grades or classes of grain which are authorized by the board from time to time.

On receipt of the board's authorizations, the grain elevator companies advise their agents at the individual points who, in turn, place orders for cars with the local railway agent. It then becomes the responsibility of the railway to supply the cars.

In this connection, the railway companies are instructed by the transport controller to spot cars at elevators at each shipping point in proportion to the outstanding orders ap-

proved for that point.

The Canadian wheat board keeps the railway companies continuously advised of the space, marketing, quota and car requirement position at each and every shipping station in western Canada so that the railway companies, to the extent that railroading operations will permit, will be in a position when supplying cars to preference such cars to the lower quota delivery stations.
