In each case their acceptability should be determined by the nature of the park, how it is to be used or intended to be used and the need.

(a) Parks which are basically scenic and nature parks. This includes Banff, Jasper, Yoho, Kootenay, Glacier, Mt. Revelstoke and Cape Breton Highlands. (b) Parks which are basically family holiday parks with a variety of activities in addition to their natural features. This includes Waterton Lakes, Prince Albert, Riding Mountain, Fundy, Terra Nova and Prince Edward Island.
