The Canadian Economy

I am bothered about the loss of production, Mr. Speaker, and I should like to read the following: It has been estimated that for every 1 per cent of unemployment increase in the range 4 per cent to 7 per cent, a country such as Canada loses some 3 per cent of gross national product. Taking a level of full employment, for example, of 3 per cent would mean that we are losing each year, at present levels of unemployment, some 6.9 per cent of gross national product. This may not sound a lot, but if I tell you that this represents some \$5 billion worth of goods lost each year to the Canadian public—that is almost \$250 lost to each Canadian man, woman and child-by the obstinacy, stupidity and arrogance of the Canadian government, you will see that there is an urgent need to change the policies and the men who lead this country. I say that with a great deal of sincerity.

Mr. Mahoney: We know what the people of Ontario are thinking.

Mr. Alexander: Is that the same overpriced Parliamentary Secretary to the Minister of Finance (Mr. Mahoney)? He is the axeman, Mr. Speaker, the one who goes around the country telling the Canadian people how well the economy is doing. If the economy is doing so well, why do we have to find this \$1 billion tonight?

Mr. Benson: Because the economy is good.

Mr. Alexander: I cannot understand how it can be said the economy is booming when we have to find \$1 billion. Mr. Speaker, I see my time has just about run out—

Mr. Perrault: It sure has.

Mr. Alexander: That was the Parliamentary Secretary to the Minister of Labour (Mr. Perrault), a man whom I respect. There is only one thing wrong—he has a big mouth. He should get up and make some suggestions, instead of continually sitting there nattering and making nonsensical interjections.

In conclusion, Mr. Speaker, for the life of me I cannot understand why it took this government so long to realize that the country was approaching a crisis before it had the gumption or even the brains to bring in these programs. Unfortunately, the type of program they brought in with respect to moneys going to the provincial governments and the municipalities takes time. I think they made a bad mistake in waiting until now before bringing in this program which we all hope will relieve some of the suffering and deprivation with which so many Canadians have been confronted for too long.
