  - Censure or non-confidence motion in guise of, 8428
  - Charges and accusations, not in order, 677, 8466
    - Against senior official of Parliament, deferring decision, 2808
    - Deferring decision, 5534, no opportunity for reply, but matter has been aired by question asked, 5579
  - Drafting, eliminating arguments, 819, 5983, 6327, 6747, 7564-5, 8111
  - Identifying dissenting voice, not in order, 4285-6, 6056, 6747
  - Irregular to put question more than once, 862
  - Matter proposed should be raised under S.O. 26, after required notice given, 5271-2, 7422

  - Not debatable until unanimous consent given, 991

- Minister making lengthy reply, should be prepared to revert to "Motions" to make statement, 1789
- Minister replying to question asked earlier, 4528
- Ministerial statements made outside House, 474, 2017, 4152-6
  - Rule, review by committee, 4193-4
- No obligation to answer, 998, 2214, 3042, 5512
- Parliamentary secretaries answering, an established practice, 4388-9
