### PARLIAMENT HILL—PARKING

#### Question No. 2,419-Mr. Forrestall:

- 1. Of the available parking spaces on Parliament Hill, how many are used by employees not working on Parliament Hill?

- Hon. C. M. Drury (Minister of Public Works): 1. Twenty-one parking spaces are provided for people visiting on business at the call of ministers, etc.
- 2. Forty-two senior officers have the use of the 16 spaces in parking areas 365. Two-hundred and thirty-five tradesmen and technicians are permitted to use the five spaces of area 1195 while performing maintenance and related work in government buildings. All other parking resources on Parliament Hill are controlled through the office of the Sergeant-at-Arms.

(b) The capability of land for wildlife, both ungulates and waterfowl was mapped for a limited part of the defined area as a part of the Canada Land Inventory program.

# TEMPERATURE-CONTROLLED RAILWAY CARS FOR TRANSPORTATION OF GOODS IN EASTERN CANADA

### Question No. 2,588-Mr. MacLean:

- 1. What action is the government taking to assure an adequate supply of modern, temperature-controlled railway cars for the transport of potatoes and other perishable products in Eastern Canada?
- 2. Is the government aware of any action by the railways to fill this need?
- 3. In the absence of action by the railways in this matter, is it the intention of the government to expand its hopper car programme to include temperature-controlled cars for Eastern Canada?

Hon. Jean Marchand (Minister of Transport): 1. We have in operation, within the Ministry of Transport, a rail car monitoring system to provide a direct information channel to and from shippers and railways in order to alleviate to some degree actual or potential car shortages and to look over the railways' freight car replacement programme. Potatoes and perishable products are given due attention within the MOT monitoring programme.

- 2. The railways are actively involved, directly with different shipper groups and indirectly, through the MOT monitoring system in considering which improvement can realistically be made to the transportation of potato and other perishable products by rail.
- 3. Through our rail car monitoring system, we are assessing the situation in respect to the supply of railway equipment for movement of Eastern Canada perishable products to market.
