also according to Clayton Research, once Phase II of the tax reform is implemented, it will cost tenants \$65 more per month per unit. What I want to ask the Minister of Finance is this: could he give the House the assurance that there are no plans for a tax that would have the effect of restricting the right to housing or the right to own property? And will the Government ensure that there will be no tax on homes for couples and families?

Hon. Tom Hockin (Minister of State (Finance)): Mr. Speaker, I would like to repeat what the Minister of Finance said in Regina on September 6. When the details of the new system are worked out, and there are still many details to be dealt with, we will see whether there is any danger that the system will stand in the way of affordable housing. If that is the case, we will do what is necessary to deal with the problem, either by providing direct assistance to private citizens and to families, or by changing the way the tax is implemented in this important sector. These measures will be taken in the spirit of consultation I just described.

TRADE

ALLEGED VIOLATION OF FREE TRADE AGREEMENT BY AMERICANS—GOVERNMENT POSITION

Mr. Dan Heap (Spadina): Mr. Speaker, my question is directed to the Parliamentary Secretary to the Minister for International Trade. The Secretary knows perfectly well that the House of Representatives and the U.S. Senate have just passed a bill that violates the trade agreement. The bill restricts imports of textiles, clothing and shoes, without the promised exemptions for Canada. Has the Government sent a protest note to the U.S. Government, since this measure calls into question U.S. support for the trade agreement with the United States? If so, what answer did it get? If not, why has the Government failed to do anything?

Mr. John McDermid (Parliamentary Secretary to Minister for International Trade): Mr. Speaker, the short answer is yes. The Canadian Government made very strong representations on the proposed legislation.

Suggestions that they are on the point of enacting this Bill are a little misleading and alarmist. Let me inform the Hon. Member that the Senate and the House of Representatives have not settled their differences on the Bill. In any event, if he looks at the votes that were taken there they cannot override a veto and the President has made the commitment that he would veto that particular Bill.

HOUSING

METROPOLITAN TORONTO—FEDERAL RESPONSIBILITY

Mr. Sergio Marchi (York West): Mr. Speaker, in the absence of the Minister responsible for housing I address my question to the Prime Minister.

The Prime Minister surely knows that Metro Toronto is in the middle of an unprecedented housing crisis in part because his Government has betrayed the traditional federal role in a national housing policy. During the last four years we have had to endure a reduction in federal non-profit housing; CMHC subsidies have fallen dramatically; federal capital funding has been cut by 61 per cent; federal grants for rehabilitation of residences has been cut by 51 per cent; and the home ownership program for first-time home buyers has been completely eliminated.

Why has the federal Government completely abdicated its responsibilities in the area of housing? Will it now, without waiting for an election call, re-establish an active federal presence in housing so that this dangerous trend in Metro Toronto, where the average home price is approaching \$230,000, can be quickly reversed?
