A SPOILED SENSATION. Harold Frederic cables from London to the New York Tmes: The rumor about Lord Rosebery's impending resignation, which was mentioned last Sunday, found its way to the public here, and enjoyed a brief, though exciting run. It is treated as quite devoid of foundation.

POOR PEACEMAKERS.

LONDON, March 17.-The unsuccessful Chinese envoys, who have returned from Japan, report in the most favorable terms of the courtesy of the Japanese officials, but declare that while in Japan they were virtually prisoners. A cordon of police at all times prevented them from having any oustide communication. The Japanese populace were intensely hostile to them.

MR. GLADSTONE'S REAPPEAR-ANCE.

A CHOICE PLUM.

LONDON, March 17.-The Speakership is one of the finest places in the State. Its emoluments are \$25,000 yearly, with a pension of \$20,000, and the retiring Speaker always receives a peerage. LONDON, March 17 .-- Mr. Gladstone has issued a second article on the observance of Sunday, in which he argues that with a true Christian it is not how much of the Lord's Day shall we give to his service, but rather of how little shall we withhold. Mr. Gladstone, who is personally a strict observer of Sunday, recently attributed his long life to the fact that he invariably kept Sunday apart from his ordinary life, and especially from his political life.

FIFTY PERSONS PERISH. TROPPAU, Austrian Silesia, March 17.-An explosion of fire damp took place yesterday in the Hohengie mine, belonging to the estate of the late Archduke Albrecht of Austria. At the time of the explosion there were 280 miners below. Of this number 80 were rescued, slightly injured.

Later in the day 80 more of the miners were rescued, but the remaining 120 are imprisoned in the galleries, which are blocked with debris. The bodies of several of the imprisoned miners have already been extricated from the ruins.

During the day twelve dead bodies were recovered, and a number of miners, fifteen of whom were injured, were rescued, and it is now believed that not more than 50 perished.

MORE BLACK-BALLING. LONDON, March 17.-It would seem that there is to be a continuation of club sensations. About a couple of weeks ago we had the refusal of the Marlborough Club, the favorite club of the Prince of Wales, to elect to membership Mr. Belt, the South African millionaire. Last week clubdom was star-tled by the black-balling of the Hon. Cecil Rhodes at the Travelers' Club, which was followed by the resignation of the Prince of Wales, the Duke of Fife and Earl Grey. Now, London has another club sensation. The famous Carlton Club has refused to elect Mr. Barney Barnato, the Johannesburg diamond king, and on the other hand, the Carlton Club elected Mr. Robinson, of Robin-

son's mine, a rival millionaire. INFLUENZA LINGERS. LONDON, March 17.—Influenza still lingers here, and the death rate touched 41.2 per 1,000, one of the highest percentages ever known in this city, where the average death rate is only 21 per 1,000. Lord Rosebery has entirely recovered from his sickness, and is spending a few days at the Durdans, his seat near Epsom. From that place the Premier will go to Deal, the wellknown sea resort on the coast of Kent. Baroness Burdett-Coutts, Mr. Henry Fowler, the Secretary of State for India, and Rustem Pasha, the Turkish ambassador to Great Britain, who have been suffering from influenza, are improving in health. Among the latest additions to the list of distinguished sufferers from the epidemic are the Earl of Pembroke and Montgomery and Sir Douglas Galton, the distinguished engineer, formerly inspector of railways and assist-

ant inspector-general of fortifications. IMPERIAL PENNY POSTAGE. LONDON, March 15.-In the House of Commons today Right Hon. Arnold Morley, the Postmaster-General, informed Mr. Henniker Heaton, M.P., that the Government had taken no steps to obtain the assent of the Canadian and the Australian Governments to the imperial penny postage scheme. The Government, Mr. Arnold continued, was well aware that some of the important couonies were opposed to the

STEVENSON'S LAST PRAYER. LONDON, March 17.-The British Weekly publishes the text of a prayer composed by the late Robert Louis Stevenson, which it appears was read aloud to Mr. Stevenson's family on the night before his death, which occurred in December. It is as follows:

"We beseech Thee, O Lord, to behold us with favor. Folk of many families and nations are gathered together in the peace of this roof. Weak men and women subsisting under the cover of thy patience. Be patient still. Suffer us yet a while longer, with our broken purposes of good, with our idle endeav-ors against evil—suffer us a while longer to endure, and if it may be, to help us, do better. Bless us to our extra mercies, and if the day comes when these must be taken, have us play the man under affliction. Be with our friends. Be with ourselves. Go with each of us to rest, and if any awake temper to them the dark hours of watching, and when the day returns to us our sun and comforter call us with morning faces and morning earts, eager to labor, eager to be happy, if happiness shall be our portion, and, if the day be marked to sorrow,

strong to endure it. "We thank Thee, and praise Thee, and in the words of Him to whom this

TO PROTECT BRITISHERS. LONDON, March 17.-Mr. Hugh Everard Hoare, Radical member of Parliament for Cambridgeshire West, and other anti-Turkish members in the Radother anti-Turkish members in the Radical section have recently been trying to obtain the publication of a collection of dispatches from Mr. Hallward, Brittish vice-counsel at Van, in regard to the Armenian atrocities. The Armenian Association professes to have learned that Mr. Hallward dilates upon the Armenian horrors, not as incidents, but as evidence of the increase of their bruis evidence of the increase of their bruas evidence of the increase of their brutalizing influences upon the Armenians themselves. The Foreign Office has refused to cause the publication of the dispatches on the ground that their publicity would prejudge the case already under investigation by the Armenian Commission of Inquiry. Mr. Hallward seems to have lent an ear to the Armenians who the correspondent the Armenians who the correspondent of the Telegraph at Kars says are "gifted with a faculty of exuberant lying beyond any other people, and are ready to invent sanguinary battles and blood curdling massacres to a degree of coherence and plausibility that would put Falstaff to blush.

AN OPPOSITION SPLIT. LONDON, March 17.-The Conservatives and Liberal-Unionists are wrangling over the representation in the seat about to be made vacant by Speaker Peel's retirement, with the result that despite the public appeals of the leaders to the rank for unity, there are at present a Conservative and also a Uni-onist candidate with the secret approval of these same leaders. The shab-by treatment accorded Mr. Courtney by his allies will probably induce him to give more frequent and stronger support to the Liberal Government, but a still more interesting case will result when Mr. Peel receives the peer-

age, which, in acordance with precedents, he is sure to do. Then the home rule party in the House of Lords will receive a powerful reinforcement, for it has long been an open secret that he has largly modified his views respecting the government of Ireland. In fact, his support by the Liberal Home Rule Association in the Warwick and Leamington constituency, which he represents in the Commons as an anti-Home Ruler, is one of the reasons why the local Conservatives insist upon running a candidate for the coming vacancy. There are some indications that the Conservative-Liberal-Unionist combination will be changed into complete organization, but it is by no means certain which way the crisis will turn.

MAUD'S POSSIBLE MARRIAGE. LONDON, March 17.-Whether the Princess Maud of Wales is or is not to marry the Prince of Naples is a question that continues to agitate English society. There have been semi-official denials that any such match is contemplated, but the gossips persist in assert-ing that nuptial negotiations are al-ready in progress and that the visit of the Prince of Wales to Italy in the spring has something to do with the affair. In some quarters the political advantages of such a match are openly discussed. It is suggested that a matrimonial alliance with the future King of Italy would be a splendid coup for England. It would in some respects lead to a readjustment of political relations which would give Great Britain more influence on the European continent. For some time there has been a disposition in Downing street to smile on Italy's rate from England as a first step, if aims in Africa. Lord Kimberly has only properly approached. Attorney-General's Law Reform Bill.

To Be Introduced at Today's Sitting of the House.

(Special to the "Advertiser.) PARLIAMENT BUILDINGS, TO-RONTO, March 17.—The bill which Sir Oliver Mowat is bringing in to reform certain legal clauses was made public yesterday, and contains some radical alterations of the present conditions. The change with regard to appeals is that cases where the amount at issue does not exceed \$1,000 or which does does not exceed \$1,000, or which does not come within certain classes of cases, are appealable directly to the divisional court of the High Court, from which a second appeal to the Court of Appeal is not allowed. The specified cases are as follows: Where the validity of a patent is affected, or where the matter in question relates to the taking of an in question relates to the taking of an annual or other rent, customary or other duty or fee, or a like demand of a general or public nature, affecting future riglety, or where the judgment or order involves a question of law practice on which there have been flicting decisions by the High Court Justice or by judges thereof; where the judgment or order is in regard to a matter of practice, but afgard to a matter of practice, but affects the ultimate riglety of parties to the action; or where there are other sufficient special reasons for treating the case as sectional.

The next change is that in cases in which the amount is more than \$1,000 or come under the cases given, the appropriate the case of the ca peal from the trial judge may be taken on the option of the appellant, either to the divisional court of the High Court or to the Court of Appeal. If the former, the party so appealing shall not be entitled afterwards to appeal from that court to the Court of Appeal but on the court of Appeal but on the court of Appeal but on the court to the court of Appeal but on the court of the section peal, but any other party to the action or matter may apply for leave to appeal to the Court of Appeal. The application shall be made to the divisional cation shall be made to the divisional court or to the judge, whose judgment or order is in question, or to the Court of Appeal or to the judge thereof. The granting of leave shall be entirely in the discretion of the judges of court appealed to. No security for costs shall be required for an official court of appeal upless such security is specialappeal, unless such security is specially ordered by the court to which the

appeal is made or judge thereof.

Printed appeal books shall not be necessary, but the court may order for special reasons the printing of any documents, proceedings or other papers in any case for the use of the court.

The divisions of the High Court are in any case for the use of the court.

The divisions of the High Court are abolished, and provision is made for the monthly sitting of the divisional court, which shall be composed of a president and two other judges of the court arranged according to or-

The divisional court of the High Court shall always be composed of three judges, from none of whom the appeal shall be taken. Non-jury actions in any county may be entered for trial at any sittings of the High Court in such

A High Court judge at either jury or non-jury sittings shall be authorized and required to determine any local matters which would have jurisdiction to determine it in getting in court or

chambers in Toronto.

No sittings for the trial of causes shall begin before 9:30 a.m., or except for special reasons extend beyond 7 p.m., with at least one-half hour's in termission at or near noon.

In a case of a compulsory reference by the judge at the trial of any action to the county judge, registrar, deputy registrar, deputy clerk of the crown, local master or other officer of the court, of any matter where it would have been competent for such judge to try himself at the trial, no fees are to be allowed to such referee.

The charges for litigants for term copies of evidence taken in shorthand at trials, refere ;, examinations, etc. shall be 7 1-2 ce per folio, instead of 15 cents as heretofore. In respect to costs in civil action, as between solicitor or client, it shall be

competent for a solicitor to make an agreement with his client as to the remuneration, either by a gross sum, commission, salary or otherwise. This agreement is subject to taxation and review by the court. Arrangement is also made for the

Arrangement is also made for the substitution of monthly or semi-monthly for weekly sittings at Ottawa by the judges of the High Court in view of the expressed desire of the Ottawa bar, and the expected reduction of work, and a similar change may be made for London if the London bar so wish.
