THE CHICAGO WHEAT MARKET IS AGAIN DEPRESSED.

Sharp Advance in Distillers—Local Stocks are Full—Decrease in the Visible Supply of Wheat—Firm Cables Lower for Corn—Cotton Steady.

MONDAY EVENING, Feb. 5. Stock speculation is quiet, and at the close of the board today the feeling is unsettled.

Canadian Pacific is dull, closing in London at 73 1/2.

Consols firmer, closing today at 99 for money and at 99 1/2 for account.

There are no changes in the price of Dominion securities in London. Montreal 4's are selling at 101, and Toronto 5's at 101.

Hudson's Bay Company stock is up a fraction, it now being quoted at 20 1/2.

The specie and legal tenders in the New York banks now amount to \$249,650,000, as against \$141,000,000 a year ago.

The continued uncertainty as to what Congress may finally do in respect to the tariff and the income tax, has caused a depression of close exchange rates.

The Wilson bill with its levitating provisions, which will now go to the Senate, where its fate will soon be determined.

Manufacturers have become restless, and have closed for months past because of the uncertainty of the tariff and the income tax.
