On the orders of the day:

Within a very few days an announcement will be made in this regard, the matter having been decided some two or three weeks ago.

# HEALTH AND WELFARE

ASIATIC FLU-STEPS TO PREVENT SPREAD

On the orders of the day:

Mr. W. L. Houck (Niagara Falls): May I ask the Minister of National Health and Welfare what I think is a very important question. Indeed, it is of importance to all members of the house as well as the people of the country generally. Before doing so, may I be allowed to congratulate him upon his elevation to a very important portfolio. This, Mr. Speaker, is my question. Has the government taken any further steps to prevent, if possible, the spread of the Asiatic flu germ which is causing so much inconvenience and distress to all the people of the dominion?

Hon. J. W. Monteith (Minister of National Health and Welfare): Mr. Speaker, first may I express my appreciation to the hon. member for his kind words concerning my elevation to the cabinet. May I also thank the hon. member for having given me notice a short time ago of his intention to ask this question.

With vaccine being produced in increasing quantities, provincial programs of vaccination are now under way. However, due to the early arrival of influenza in epidemic proportions in some provinces and the expectation that it might subside in a matter of a few weeks, most provinces have indicated their reluctance to make any commitment for vaccine beyond November 15.

In addition to meeting the requirements of the federal-provincial immunization program it has been possible, through the co-operation of the laboratories and the two senior levels of government, to provide facilities for the production of increasingly large quantities of vaccine which will be made available through the usual channels to the medical profession for protection of those not included in provincial programs.
