INCOME TAX

REGULATIONS AFFECTING EXCHANGE TEACHERS—MOTION UNDER S.O. 43

That the Minister of National Revenue be directed by this House to initiate changes in the income tax regulations so that Canadian exchange teachers may also be included in Section 8(10) of the Income Tax Act to alleviate the financial burden facing the exchange teachers of Canada.

STATUS OF WOMEN

CONDEMNATION OF MINISTER—MOTION UNDER S.O. 43

Mrs. Margaret Mitchell (Vancouver East): Madam Speaker, I rise under the provisions of Standing Order 43 to move a motion concerning the status of working women. Today's *Globe and Mail* quotes Ontario studies which prove that the largest single factor in the 40 per cent lower wage rates for women is occupational discrimination and that affirmative action programs have the most potential for reducing the wage gap between men and women. Inasmuch as the minister purportedly responsible for the status of women indicated in committee last night that she has back tracked on mandatory affirmative action in favour of a go-slow policy, even on voluntary affirmative action in the Public Service, I move, seconded by the hon. member for Beaches (Mr. Young):

That the minister purportedly responsible for the Status of Women be condemned strongly for relegating hundreds of thousands of working women to low paying, low status, dead-end jobs for the rest of their working lives.
