up a bit so that we are less cluttered. Yesterday and again today I requested copies of *Hansard* for the month of October just past. I have been informed that those copies are now kept in the Confederation Building and that it takes 15, 20 or 25 minutes to arrive to a Member who happens to be in his or her place in the House of Commons. I was wondering whether, in your capacity as administrator, you could see that copies of recent *Hansard* are kept in a location that is much more available to Members of the House so that, as we do our work in this Chamber, we can have access to the written record.
