Indian lands to provide that the Governor in Council may make regulations respecting the disposition of any interest in Indian lands necessarily incidental to the exploitation of oil and gas thereon and regulations prescribing the royalties on oil and gas obtained therefrom; and to provide for a special agreement with the approval of the band council concerned for a reduction of such royalties.

The Order being read for the second reading and reference to the Standing Committee on Labour, Manpower and Immigration of Bill C-12, An Act to provide for the resumption of grain handling operations on the west coast of Canada;

Mr. Munro (Hamilton East), seconded by Mr. Turner (Ottawa-Carleton), moved,—That the bill be now read a second time and referred to the Standing Committee on Labour, Manpower and Immigration.
