## TWENTY-SIXTH Balfour Formally CAMPBELL-BANNERMAN IS CALLED NEW CABINET UNDER WAY

Event Not Such a Surprise as Has Been Intimated, and Liberal Plans Have Long Been Prepared—John Morley in the Role of Chief Adviser—Labor Party and Nationalists May Ally.

### SIR HENRY CAMPBELL BANNERMAN

has just entered his 70th year. As the Liberal leader since 1890, he has had a long time. He is recognized as one of the ablest statesmen in Europe, in spite of the epithet "the past master of ambiguous pawliness," applied to him recently in an anonymous article in The Daily Mail. He is a Scotchman, and has held various offices, including secretary of state for war and chief secretary for Ireland.

London, Dec. 4.—The political crisis in the United Kingdom reached a climax today when Arthur J. Balfour, the premier, formally tendered the resignations of himself and the members of his cabinet to King Edward, who accepted them. His Majesty has invited Sir Henry Campbell-Bannerman to an interview to-morrow morning, when he will offer him the mission of forming a new cabinet. Sir Henry will accept the task, and within a few days, even within a few hours, a new government will be formed.

A brief official announcement was made to-night that the cabinet had resigned, that the king had accepted the resignations of his ministers, and that Sir Henry Campbell-Bannerman had been sent for. It would now appear that the entire program has been cut and dried for some time, and it is even probable that the Liberal leader has already completed his cabinet, the list of which is being circulated in connection with British officialdom, must be left to him.

Rosebery Not in It.  
It may be stated as certain that Lord Rosebery will be entirely ignored in the make-up of the new cabinet, and that John Morley will be one of the chief advisers of Sir Henry in drawing up the list of his official family, which will be presented to his Majesty.

Mr. Morley himself is considered likely to go to the Indian office, and it is probable that Herbert Henry Asquith will be Chancellor of the Exchequer, while John Morley will be one of the chief advisers of Sir Henry in drawing up the list of his official family, which will be presented to his Majesty.

The Irish Issue.  
One thing is certain—that Sir Henry Campbell-Bannerman has explained his attitude on home rule for Ireland to those Liberal leaders who are known to be opposed to home rule on the lines of the last bills introduced in parliament, and at the same time avoid raising the issue as one of the most prominent planks in his platform.

An interesting feature of the political situation is the prospect of a special alliance between the Irish and the Labor parties in the new parliament. James Keir Haggis, the Scottish and independent member, in a political speech to-night invited such an alliance, and particularly in connection with the government of Ireland.

Ireland Before the Cabinet.  
Speaking at Whitehall, Lord Balfour said the importance of the colonies was as nothing compared with the good will and friendship of Ireland. They contributed nothing to the expenses of the empire, but were a considerable expense and a liability against England, for if attacked to-morrow all the resources of the empire would be placed at their disposal.

Washington, D.C., Dec. 4.—Many bills and joint resolutions were introduced in the house to-day. They cover a large variety of subjects, including Philippine tariff, statehood, pensions, regulation of the hours of employment in the executive departments, merchant marine, increase of salaries of the vice-president and members of the cabinet, requiring corporations to make full reports of their affairs to the commissioner of corporations, increasing the powers of the inter-state commerce commission; investigation of campaign funds; expenditures on the Panama Canal; of insurance companies doing an inter-state business; of cotton reports, and of the condition of child labor; provision for a six-year term for the president and the election of United States senators by direct vote of the people.

Representative W. A. Smith (Michigan), introduced a resolution asking that the secretary of the navy investigate the treaties between Great Britain and the United States, which prevent the United States from having more than one warship on the great lakes at one time. The resolution states that this provision makes it impossible for American shipyards to engage in the building of warships on the great lakes. Representative Hearst (New York), introduced a bill to increase the powers of inter-state commerce commission, and to expedite the final decision of cases arising under the act to regulate commerce by creating an inter-state commerce court. This bill was introduced by Mr. Hearst in the last congress. He also introduced a measure providing for the election of United States senators by direct vote of the people, and "to enable the United States of America to acquire, maintain and operate by sale of bonds redeemable out of the net earnings."

Joseph C. Cannon (Illinois) was elected speaker of the house.

Resolutions on Tariff.  
Representative Williams (Mississippi), the leader of the minority in the house, today introduced several bills and joint resolutions affecting the tariff and campaign contributions. Mr. Williams said to-day that other bills will be looked for, but from his standpoint the authority of the first step in the right direction, and an invitation to the Republican party to declare good intentions.

Mr. Williams also introduced a bill to authorize the imposition of an income tax.

The Philippine tariff bill provides that all articles, the product and growth of the Philippines, shall be admitted into the United States free of import duty, and that all articles, the product and growth of the United States, shall be admitted into the Philippines free of import duty.

Another bill proposes to establish a minimum tariff of the United States. It declares the existing tariff schedule to constitute the maximum tariff of the United States, and a reduction of 20 per cent. from them or rates equal to four-fifths of the existing duties to constitute the minimum tariff of the United States. The bill extends the operation of the minimum tariff to all such countries as grant admission to their markets of articles, the product and growth of the United States at the minimum tariff rates levied by them.
