FORMER LIFE

A Statement by the Prisoner in London Jail.

His Career Before Coming to Canada Described

By the Peg-Leg Himself-A Rather Eventful History.

The following is a statement of Marion Brown, respecting his former

I was born in San Saba county. Texas. My father was a white man, my mother was a colored woman. I never knew my father. When four or five years old we moved to Austin, Texas, and soon after to Round Rock, Texas. We lived in Round Rock until 1 was twelve or fourteen years old. My mother was employed as a cook on different farms, and I and my sister lived with her. I went to school for three or four months each year, and every spring and fall after I was seven or eight years old I worked at hoeing and picking cotton. Hoeing lasts from June to August, and picking from that time until December. All this time my sister and I worked for my mother. My sister, who is older than I, was

married when I was about fourteen, and soon after I left Round Rock and went to Belton, where she lived, and worked as a boot-black in my brotherin-law's barber shop for about six months. With another lad, Jim Cox, I left Belton and went to Hueston, and got employment in the Capitol Hotel, washing dishes. Getting home-sick here, I left Hueston and started for home. A colored friend of mine was braking on the train, and helped me to a ride. I was riding on a lumber car, when the conductor found me and made me jump off. It was then I broke my leg. Some colored folksection men-found me, and took me on a handcar to Courtenay, the nearest town. My mother came for me, and took me to Taylor, where she was cooking on a stock farm. Here Drs. Doke and Brown took my leg off, as I had no doctor before to save it. I was laid up for about six months, and after I got well I went back to Round Rock. Here I made myself a wooden leg, and got employment in a livery stable. Here I fell in with a man, "Ruffian" Greydenden, who taught me to play cards and gamble. This was in the summer, and in the fall I went into the cotton fields. I lived in Round Rock for about two years at this time, working in the cotton season. I a good cotton picker, and earned good wages, working for nearly all the

farmers in that part.

In the second year we heard that there were better wages at San Marcos, and a number of us left Round Rock and went over there, where we worked. Here there were a number of Mexicans, and "Ruffian" Greydenden and I got gambling with them, and between us made about \$600. On our way back to Round Rock, Greydenden and I stopped at Austin, and had several suits of clothes made. I went back to Round Rock, and put up at Hannah Washington's, a woman who was a friend of ours as long as I can remember. I went to visit my sister at Belton, and while I was away my clothes were seized, and when I returned I was arrested on the charge of having stolen the clothes. I was taken to Georgetown jail, where I was kept for nearly two months without kept for nearly two months without a trial, when the sheriff came and told me that they had found the clothes were mine, but I was wanted for gambling and fighting. On this charge I was fined \$50, and having nothing to over, went to San Angelo, where my sextended to the country. pay, I was sentenced to the county farm to work this out. On the farm we got 50 cents a day every day we worked. When sick, or if it rained, we were charged 50 cents a day for board. I worked here for about 150 days, and had about \$10 still to work off; when, getting a good chance to

escape, I ran away. I went to Rockdale, and was in that part for about a month, when I was caught and taken back to a city farm (the county farm had been sold to pay for a new jail), where I was charged with \$60, and had to stay until this was worked off. This farm had to be cleared, and I was set to chopping, work I had never done before. I was not able to keep up with the gang I was working with, and the overseer ordered me to be flogged. I got 60 lashes with a cartridge belt. I was here for the greater part of a year, and worked the amount all off. I was hardly treated here most of the time; but toward the end of the term

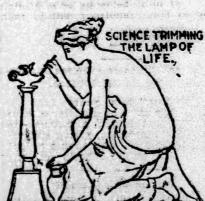
