

So far the revolutionists have had the better of the fights. From authori- tative sources it is stated that the Albanians have been winning conflict after conflict by superior strategy. A number of Abdul Hamid's leading officers are leading the rebels. They hope to overthrow the present regime and restore Abdul Hamid to the


