

you as for the purpose of obtaining your advice and assistance in all weighty and arduous affairs which may the State and defence of our Dominion of *Canada* concern, We have thought fit to summon you to the Senate of Our said Dominion, and We command you, the said *Henry Adolphus Newman Kaulback*, Esquire, that all difficulties and excuses whatsoever, laying aside, you be and appear for the purposes aforesaid, in the Senate of Our said Dominion, at all times whensoever and wheresoever Our Parliament may be in our said Dominion convoked and holden ; and this you are in no wise to omit.

In Testimony Whereof, We have caused these Our Letters to be made patent, and the Great Seal of *Canada*, to be hereunto affixed. Witness, Our Right Trusty and Well-Beloved, The Right Honorable *John*, Baron *Lisgar*, of *Lisgar* and *Bailiesborough*, in the County of *Cavan*, *Ireland*, in the Peerage of the United Kingdom of *Great Britain*, and *Ireland*, and a Baronet, one of Our Most Honorable Privy Council, Knight Grand Cross of Our Most Honorable Order of the Bath, Knight Grand Cross of Our Most Distinguished Order of Saint *Michael* and Saint *George*, Governor General of *Canada*, and Governor and Commander-in-Chief of the Island of *Prince Edward*.

At Our Government House, in Our City of *Ottawa*, in our Dominion of *Canada*, this twenty-seventh day of March, in the year of Our Lord, One Thousand, Eight Hundred and seventy-two, and in the Thirty-fifth year of Our Reign.
