Parnell and His Party.

LONDON, Nov. 27.—Yesterday's events did not relieve the tension, but rather accentuated the complications of the situation. Mr. Gladstone's letter produced a strong impression upon the Nationalists, and from the indications given at the hastily summoned meeting it seemed that there was every reason to believe that yesterday would bring about new developments which would lead to an amicable arrangement of the trouble. But although the conference proved that Parnell is firmly resolved to adhere to his decision, and that unless a vote of non-confidence is passed by his followers he will not resign the leadership. After a long and earnest discussion of the situation, in which the most candid and outspoken opinions were given, Parnell positively gained a victory. The members, however, who advocated his retention, deprecated the idea of a final decision until the opinion of the entire party shall have been recorded. The meeting adjourned at midnight, after three hours of speaking, in order to obtain the views of the absent members of the party. A careful inquiry brings out the fact that little doubt exists as to the result of the matter. When the party re-assembles on Monday it is probable Parnell will again be urged to retire by a section of his supporters, but already a reaction in his favor has set in, and if a vote is taken it is expected a large majority will be found on his side.

The meeting of the Parnellite members of the House of Commons, after the letter from Mr. Gladstone to Mr. Morley had been made public, was a stormy one, and the action of Mr. McCarthy in not making known the contents of the letter to the meeting, after the meeting of the Parnellites yesterday morning was severely criticised. A majority of the Nationalist members present said they had believed, previous to the meeting, that Mr. Parnell, after his re-election, would not take an active part in politics for a few months. They now believe, if Mr. Gladstone's letter had been read at the morning meeting, the vote to retain Mr. Parnell as leader would have been different. Another meeting was held yesterday afternoon at which Mr. Parnell presided. He explained that he reconsidered his determination and had called the meeting at the request of the members of the party. The meeting lasted for half an hour. There was great divergence of opinion manifested throughout the discussion. No definite action was taken, and the meeting adjourned to reassemble at 5 in the evening. Parnell's speech gave no indication that he intended to alter his decision to retain the leadership. Mr. Nolan was the only member present who favored Parnell's retention of the office. Mr. McCarthy, whose frequent allusions to Mr. Parnell's great sacrifices to the Irish cause were applauded, said he hoped that after due consideration Parnell would see his way clear to retire for the present and save the sacred cause of Irish independence. It is stated that at the midday meeting of the Parnellites at least 50 favored retaining Parnell as leader. Several members, however, had written their resignations and were ready to present them in the event of a decision that Parnell should remain. In the latter case a meeting of the Parnellites was to be called to express confidence in Gladstone and to appeal to him to continue as leader of the party.

United Ireland says: The decision of Mr. Gladstone and other most faithful friends of the cause of home rule alters the situation. It is useless for us to shut our eyes to the fact that their defection will indefinitely prolong the reign of coercion in Ireland and postpone the triumph of the home rule movement. Our fidelity to Ireland overrides fidelity to Parnell. The London Star (Home Rule) says: Mr. Gladstone's letter was designed to read at the Parnellite meeting, at which it was voted to retain Mr. Parnell in the leadership of the Irish party. Somewhat later was read Justin McCarthy's letter, in which Mr. Gladstone's opinion that a change in the leadership of the Irish party was essential, but in the haste of Mr. Parnell's arrival Mr. Gladstone's opinion was not fully impressed upon him. Mr. Parnell's sudden presence, his past services, the outside pressure of the situation, the instinctive Irish loyalty prevailed over the duties of the Parnellites as to the necessity of the situation. The press of the party are now opened to the significance of the affair in England, which is nothing less than whether home rule will be passed upon at next general election, or be indefinitely shelved. Had the Parnellites known this they could have come to but one conclusion. We believe they will come to that conclusion yet. In conclusion, the Star says it is evident that as patriots the Home Rulers have no alternative but to pass a resolution that will enable Mr. Gladstone to give the remainder of his life to his cause.

Dr. Cummins, Nov. 27.—A dispatch from Kildare says: If Parnell retires from the leadership of the Irish party, the branches of the National League in West Clare will discontinue their purely local work. Mr. Parnell, having received such marks of sympathy, should remain at the head of the Nationalist party, notwithstanding Gladstone's letter.

CIRKINNATI, O., Nov. 27.—Wm. O'Brien said to a reporter that the subject was a delicate one, and he did not care to express himself further than what was contained in the following dispatch, which he sent to friends on the other side:

In view of our obligations to Mr. Gladstone, the great object of our duty, and the responsibility we have contracted to the Irish people, we earnestly recommend the party to open into friendly communications with Mr. Gladstone.

LONDON, Nov. 27.—The suit brought last spring by Mrs. O'Shea against her husband in the Chancery Court of Chancery for the enforcement of her marriage settlement and to compel Capt. O'Shea to transfer to her certain interests which were menaced by bankruptcy proceedings taken against him, has been withdrawn.

In the House.

LONDON, Nov. 27.—When Mr. Gladstone entered the House of Commons yesterday morning he was loudly cheered by his friends. Mr. Parnell was also present and occupied his usual seat. Leave was granted to Mr. Gladstone to introduce his bill removing the disability preventing Catholics from becoming Lord-Lieutenants of England or Lord-Lieutenants of Ireland.

A Train Derailled.

CARLEISLE, Nov. 27.—An accident occurred just outside the railway station here yesterday morning. The engine of a special train, consisting of the carriage and a van, conveying Mr. Malcolm, and officer of the Scots Greys, and servants to Longhollow, the North British Railway, being derailed, fell over a bridge. The driver was killed and the fireman seriously injured, but Mr. Malcolm, the servant and guard escaped unhurt.

The Stanley Dispute.

LONDON, Nov. 27.—Mr. Quilter, editor of the Universal Review, who recently attacked Stanley in that publication, accusing him of opening a box belonging to Jameson after the latter's death and reading his diary and some private letters which it contained, writes to the Times that Stanley's innocent general denial of the charges is to be regarded as absolutely worthless. He says he did not bring his charge against Stanley on Bonny's authority.

Vulgarity in the House of Lords.

LONDON, Nov. 27.—Lord Salisbury, in a speech in the House of Lords, on Tuesday, said the Parnellites had various modes of escaping, some preferring vulgar modes of escape. The Chronicle (Vice) describes this gibe as vulgar and undignified, and adds: "Lord Salisbury might have remembered that he was addressing a chamber where at least half a dozen of the terms of virtue as Marlborough, St. Leonards and Allibury."

Birchall's Brother-in-Law.

LONDON, Nov. 27.—The London Times says: On the day on which Birchall, the Benwell murderer, met his fate, his brother-in-law, James West-Jones, coroner for the borough of Hales, Staffordshire, was arrested and lodged in the cells. West-Jones is a solicitor by profession, but he was recently struck off the rolls. Some months ago he obtained a misapprehension some more belonging to the Stanley Starr Bowkitt Society. Proceedings were taken; he was brought up at the local Police Court, and after the intervention of friends, a fine was inflicted, and the prisoner being also ordered to pay the

amount missing, £113, or in default he imprisoned for three months. He failed to pay the money within the requisite time, but escaped was rescued. He has since continued to exercise his office of coroner for the borough.

Horror of the Siberian Kameras.

ST. PETERSBURG, Nov. 27.—Terrible stories are told regarding the kameras, or apartments, where men and women are temporarily imprisoned at Tomsk, Siberia. It is said that the condition of affairs in the kameras is horrible. The women prisoners, many of them of respectable training, are at the mercy of the guards, and also of any other prisoners who bribe the guards for permission to use the kameras. The Empress of Russia is said to have induced the Czar to order an investigation.

Cantharidin in Egypt.

LONDON, Nov. 27.—A dispatch from Suez says that the desert chief Senousi is marching against the Mahdi with a large and well-armed force, and that the Mahdi, who is said to be a powerful man, is being followed by hundreds of Arab living in Khartoum. It is a no condition to meet the enemy. In Khartoum and vicinity all the food has been seized for the support of the Mahdi's army, and the inhabitants are suffering from lack of food. A large number of the inhabitants are said to have been killed or driven away from their homes, and the Mahdi is said to have been seen in the city.

Experiments with Lymph in London.

LONDON, Nov. 27.—An interesting series of experiments were begun yesterday in the laboratory of the Royal College of Physicians, in which the lymph of a patient suffering from tuberculosis was injected into four patients, one of whom was suffering from tuberculosis of the foot, another from lupus in a severe form, and another from phthisis. Watchers have been selected who will take notes in the effects of the inoculation. A large number of doctors and students were present to observe the method of treatment.

Actual Starvation in Ireland.

DUBLIN, Nov. 27.—A story of acute destitution has been received from the island of Achill, in the West of Ireland, where the potato crop is utterly exhausted and the stormy weather prevents the people from fishing. Relief has been sent to Achill from the adjoining mainland, but there is still a great need of assistance. In one of the cabins on the island a new-born babe perished, the mother being unable to give it nourishment, owing to her own starving condition.

The situation at Falcarragh, where the people are absolutely starving, and the workhouse is unable to accommodate the applicants for relief.

London Society Dispute.

LONDON, Nov. 28.—While the poor are looking forward to the struggle of winter, London society is beginning a gay season. The Prince of Wales, who recovered from the slight indisposition which hastened his return from Austria and caused some anxiety to his royal mother, is now in the city, and is expected to look heartier than she has for years past. She seems to have all the vigor of George III, without his mental weakness, and the Prince of Wales is expected to be a great help to her.

PERILS OF THE SEA!

Two British Steamers Go to
the Bottom.

Forty Fishing Boats Sunk on the Nor-

LONDON, Nov. 27.—The British ship Sultana, Capt. McTear, from Hamburg for Rangoon, has been sunk in a collision off Dungeness. Eleven of her crew are missing.

LOST EIGHTEEN MEN.

LONDON, Nov. 27.—The British steamer Westbourne, from Feodosia, Russia, for Hull, has been wrecked in the Black Sea. Six of her crew were killed, twelve died from exposure and five landed at Feodosia.

DELAWARE BREAKWATER, Del., Nov. 27.—The steamer Pennsylvanian, from Liverpool, which passed the Cape yesterday, signaled that the British steamer Falcon had been abandoned by her crew. The steamer sailed from New York for Glasgow, Nov. 2.

ABANDONED.

QUERBEY, Nov. 27.—The crew of the schooner Dominion, previously reported captured by fire off Sicily, arrived here Tuesday and were forwarded to their homes in Carlsberg, Newfoundland. The fire on their vessel was caused by a lamp explosion among the lumber in the hold. The crew saved a portion of their effects.

THE ALPINE'S RIGOR PASSAGE.

HELVETIA, Nov. 27.—The steamer Alpide, the first of the Donaldson Line this season, arrived yesterday morning. She had continued westerly gales, sometimes a hurricane. On one day she made but 80 miles. Part of a proper blade was broken. She was also thrown on her beam ends by the shifting of a large quantity of fire brick, etc., and in the midst of the gales it took several days to bring her back properly. Three of five splendid Clydesdale horses for Ontario died. The surviving two will be sent from here by rail. A large marble monument to the memory of the crew was placed on the shore.

CHARLIE ROSS RESURRECTED.

THE LONG-LOST SAID TO HAVE BEEN FOUND AT LAST.

NEW YORK, Nov. 27.—The World's special from Philadelphia says: It is more than probable that Charlie Ross, the long-lost kidnapped son of Christian Ross, has at last been found. The detective bureau at New York police headquarters soon received a letter from Philadelphia, which convinced them that they had discovered the boy. Charlie A. Grant, chief clerk of the police commissioners of New York, diligently worked the case down to the point, where Inspector Byrnes was consulted, and the great video of the New York police apparently thinks it worth a close investigation.

About three months ago Mr. Grant received information from a lively stable-keeper that he knew a woman who had told him that she was Charlie Ross. He was to be found and that he was alive and had been brought up by relatives of one of his abductors. Mr. Grant investigated the story and found the boy in the hands of a woman living with a family named McHenry at 174 Park avenue. Grant congratulated himself on the confidence of a chum of his who, by a direct questioning prompted by Mr. Grant, learned things which convinced him that he was on the right track.

The boy admitted to his chum that the McHenry's were not his parents and declared that he was Charlie Ross. He described almost accurately what was known as the abduction, about being taken away in a carriage and being kept on a boat for many days.

When asked why he did not go back to Philadelphia to his parents, he replied: "My father is dead and my mother is in the lunatic asylum." The boy was known to his companions as Charlie McHenry. He is fair-faced and has light hair, with curls clustering around his forehead. He has well-shaped features, and is much more delicate looking than other New York lads brought up in the same social atmosphere. He has been a good boy until recently, when by some circumstances he was forced into bad company. Recently Charlie ran away from home and could not be located until a few days ago, when his chum got a letter from him, dated at Boston, in which he stated that he had been arrested for stealing a value. He said that a boy acquaintance he had made had committed the theft, and that by force of circumstances he had been arrested for the crime, but he soon seemed to know the object of the surgery, and bore the pain quietly until the wound was bandaged and the ropes removed. Then he kicked Dr. Gordon's hand and seemed grateful for the deed.

FOUND FLOATING IN THE LAKE.

FOREST, Nov. 27.—The body of what appears to be a sailor was found yesterday on the lake shore, north of Canbyville. It was about 5 feet 8 inches in height, dark eyes, sandy complexion, top of head bald, body well developed, red moustache, no whiskers, teeth sound and complete, clothing mixture red and black, coarse short coat, blue vest with black buttons, a colored, laced-up shirt, cottonade pants, red stockings and gaiters, right arm tattooed with the letters W. J. C., left arm tattooed a picture of a woman, an anchor, a heart with an arrow through it, and some letters which, under a magnifying glass, looked like W. J. Conley.

BLOODSHED IN MONTANA!

Reports of a Fierce Battle Between
Indians and Militia.

The Cheyenne River Indians Stop Dan-
cing and Ask for Rations.

CHICAGO, Nov. 26.—A special from Missoula, Mont., says a fierce battle is in progress between the military and the Indians near Fort Keogh, Mont. The department has ordered three companies of Fort Missoula to the scene of the trouble. Advances from various points say lively skirmishing is in progress all along the line.

DON'T WITL DANCING.

WASHINGTON, Nov. 26.—The War Department to-day received news that the Cheyenne River Indians have abandoned their ghost dance and come in for rations. This is regarded as a most hopeful sign of abatement of the excitement.

RAIDING THE HOMES OF SETTLERS.

PINE RIDGE, S. D., Nov. 17.—Word was received through the Government courier Tuesday evening that 200 lodges of Blood Indians were raiding the homes of settlers in the vicinity of Porcupine Creek. These settlers themselves had left in terror a week ago. They abandoned all their household goods together with the stock. There are six persons usually in an Indian lodge and the marauders therefore are supposed to number about 1,200. The agency at Wheaton and its command, consisting of four companies from Fort Omaha, has arrived in camp and consultation with officers on the situation was at once held. An order was issued postponing the beef issue and ordering all strangers, except newspaper correspondents, off the reservation. There are about 3,000 Indians in the agency. One hundred more Indian scouts are being sworn in, and are armed for service. The Indians seem to be in a state of nervous terror. They say they do not want the soldiers to kill them, nor do they want to give up their arms, but will do so if the soldiers insist upon it.

THE SITUATION AT PINE RIDGE.

WASHINGTON, D. C., Nov. 17.—Special Agent Cooper, at the Pine Ridge Indian agency, has telegraphed Acting Indian Commissioner Bell that the situation there is unchanged. "The turbulent element," he says, "are restless, while the loyal acquiesce and satisfied. The agent says he does not anticipate trouble that will lead to bloodshed."

Died Under Suspicious Circumstances.

PORTRON, Mich., Nov. 27.—About 11 o'clock last night a man was found lying between the sidewalk and the house on the corner of Huron avenue and Beers street. The prisoner, thinking him intoxicated, took him to the station and locked him up. He was in the jail about half an hour when he died. On examination it was found that his skull was fractured. It is supposed that he got into a row and received injuries that resulted fatally, but no one seems to know anything about it. His name was James Watson, a black driver. He leaves a wife and mother to mourn his untimely death.

Struck by a Grand Truck Train.

WAYNE, Mich., Nov. 27.—Tuesday afternoon John Baxter, a farmer of Romulus, was with a serious accident. He had been to Detroit with a load, and was on his way home. He and some others were waiting for a freight train on the Michigan Central to pass at Ruthtown crossing, about 40 rods east of the country house. A freight train was going east, and as soon as it had passed the people began to cross, Baxter being behind. Just as his horse was across the track the Grand Rapids passenger train, coming from the east, struck his horse, killing it instantly, and throwing Mr. Baxter into the cattle guard and covering him with fragments of his buggy. His left arm was broken, several ugly gashes cut in his head and face, and he was bruised badly from head to foot. He is still alive, but no hopes of recovery.
