Mr. Crocket, from the Select Standing Committee on Miscellaneous Private Bills presented the Sixth Report of the said Committee, which is as follows:—

Your Committee have considered the following Bills from the Senate, and have agreed to report the same without amendment, viz.:—

Bill intituled: "An Act for the relief of Minnie Edna Brownell."

Bill, An Act respecting Ottawa and Montreal Transmission Company, Limited.

Bill intituled: "An Act for the relief of Charles Albert Fowler.

Bill intituled: "An Act for the relief of Otto Clarence Peterson."
Bill intituled: "An Act for the relief of Harold Moss Hampson," and

Bill intituled: "An Act for the relief of Alexander Zépherin Gonier."
Your Committee have also considered the amendments made by the Senate to

tour Committee have also considered the amendments made by the Senate to the following Bills, and have agreed to report the same without any amendment, viz.:—

Bill to incorporate the New Westminster Harbour Commissioners. Bill to incorporate the North Fraser Harbour Commissioners, and

Bill to incorporate the Canadian Medical Protective Association.

The Promoters of Bill respecting Patents of the Johnston Harvester Company, having signified their intention of not proceeding further with the measure during the present session, Your Committee recommend that the said Bill be withdrawn, and the fee and charges paid thereon refunded, less the cost of printing and translation.

Mr. Ames, from the Select Standing Committee on Banking and Commerce presented the Seventeenth Report of the said Committee which is as follows:—

Your Committee recommend that leave be granted to them to sit this day while the House is in session, for the purpose of hearing parties who have been invited to appear before the said Committee in connection with Bill respecting Banks and Banking.
