2. Motion (Mr. Knowles)—That hours of evening sittings of the House be from 7.30 p.m. to 10.30 p.m., during the Debate on the Address; moved, 104. Agreed to, after debate and on division (yeas 110; nays 82), 104.
3. Motion (Mr. St. Laurent)—That hours of evening sittings of the House be from 7.30 p.m. to 10.30 p.m., up to and including the last sitting day in April, moved, 145. Debate adjourned, 145. Debate resumed, 196. Amendment (Mr. Drew)—afternoon hours to be from 2 to 6 p.m., each day and evening hours 8 p.m. to 10 p.m., moved, 196. Amendment negatived, on division, 196. Main motion agreed to (yeas 80; nays 68), 197.
4. Motion (Mr. Drew)—That House do not rise at 6 o'clock p.m., this day; moved and negatived, 178.
5. Motion (Mr. St. Laurent)—morning sittings from 11 a.m. each day from Friday, March 18, 1949, until emergency legislation has been disposed of and Saturday sitting on March 26, 1949; moved and agreed to, after debate, 218.
6. Motion (Mr. St. Laurent)—House to continue sitting after 10.30 p.m. this day; moved and agreed to, 268, 346, 405.
7. Motion (Mr. St. Laurent)—*re* morning sittings; Wednesday evenings; precedence for Government Business; suspension of Standing Order 28, moved, 383. Amendment (Mr. Drew)—*re* Old Age Pension legislation, moved, 383. Ruled out of order, 383. Ruling appealed and sustained (yeas 149; nays 44), 384. Main motion agreed to, on division, 385.
8. Motion (Mr. St. Laurent)—*re* sitting on Saturday, April 30, 1949—hours and order of business to be the same as on Friday, April 29, 1949; moved and agreed to, 401.
