## CHINESE STUDENTS.

# Mr. STEVENS:

1. How many Chinese students have been given free entry to Canada through the ports of the Pacific Coast during the years 1917,1918?

2. What is the definition of a student under the regulations of the Immigration Act?

3. Has the Government been advised, or is it aware that large numbers of Chinese are entering Canada as students who are not bona fide students?

4. Has the Government recently received any requests from representatives of the Chinese Government in Canada or from other sources to enter into such arrangement with the Chinese Government as will result in voluntarily restricting Chinese emigation to Canada?

1. 1917, one; 1918, three.

2. The definition of "student" under the Chinese Immigration Act is as follows: "Students coming to Canada for the purpose of securing a higher education in any Canadian college or university or other educational institution approved by the minister."

3. It has recently come to the notice of the Government that a number of Chinese, who entered Canada within recent months, declaring themselves to be students, are not now attending school. These Chinese were not admitted as exempt from the head tax, but paid the head tax, declaring at the same time that they would attend school in Canada.
