We were, at the time, assured by the Quebec government engineers that this section, which is vital for the world fair, will also be completed in time for the fair.

Hon. Leon Balcer (Three Rivers): Mr. Speaker, may I ask a supplementary question? Could the minister give us the real reason for the resignation of Messrs. Bienvenu, Carsley and Robillard?

Mr. Deschatelets: Mr. Speaker, when Mr. Bienvenu and Mr. Carsley handed in their resignations, which were regretted at the time, they gave their reasons for doing so and it would not be proper for me to add anything to what they said.

Mr. L. J. Pigeon (Joliette-l'Assomption-Montcalm): Mr. Speaker, speaking of roads of access to the fair, could the minister tell the house if the federal government will contribute about 90 per cent of the construction cost?

Mr. Deschatelets: Mr. Speaker, as regards work on the trans-Canada highway, the federal contribution is provided for in the Trans-Canada Highway Act and it will be the same in this case as in the other provinces.
