That Bill C-144, an act to provide for the management of the water resources of Canada including research and the planning and implementation of programs relating to the conservation, development and utilization of water resources be amended by adding immediately following the word "prescribing" in subclause (1)(a) of clause 16 on page 18 the following:

"from time to time specific water quality standards and levels applicable to all bodies of water under the jurisdiction of the Canada Water Act for the following."
