Inquiries of the Ministry

and the recommendation with respect to improvements of the landing brake system are to be ignored?

Mr. Jamieson: No, Mr. Speaker.

Mr. Speaker: Order, please. I will allow the minister to reply to the question because of the delicacy of the matter. I think that normally such a question would be ruled as being argumentative. Perhaps the minister should be allowed to reply to the question.

Mr. Jamieson: Thank you, Your Honour, for your consideration, because it is a matter that I would not want held in abeyance. My statement was very carefully worded, and I repeat it now. We are completely satisfied about the airworthiness of this particular aircraft, if the operating manual and instructions are followed. I think that is simply reflecting the views of Mr. Justice Gibson.

On the larger question, we conveyed the findings to all appropriate parties in the United States. As the hon. member and the House will appreciate, this question is one that has to be negotiated internationally, because it is not simply Canadian aircraft that are involved or Canadian aircraft which are flying over Canada. I want to emphasize that the airworthiness of the aircraft is not in question provided proper procedures are followed. It is my information that they are now being followed to the letter by all Canadian carriers.
