INTERPROVINCIAL MARKETING—FEDERAL INTERVENTION
IN PROCEEDINGS BEFORE SUPREME COURT RESPECTING VALIDITY OF PROVINCIAL REGULATIONS

Hon. H. A. Olson (Minister of Agriculture): Mr. Speaker, I will consider that very interesting suggestion and discuss it with the Minister of Justice.

Mr. Baldwin: In taking it into consideration, will the minister bear in mind that it is the understanding that the case will be before the Supreme Court of Canada very shortly and if the government is going to intervene it should make up its mind to do so at once and instruct counsel accordingly?
