INDEMNIFICATION OF VICTIMS OF THALIDOMIDE—
GOVERNMENT POSITION

Mr. Marcel Prud'homme (Parliamentary Secretary to Minister of Regional Economic Expansion): Mr. Speaker, I should like to put a question to the Minister of National Health and Welfare.

Owing to the recent decision rendered in Great Britain which has compelled the company responsible for the distribution of thalidomide to assume the financial responsibility for afflicted children, can the minister assure the House and the country that the government is seriously considering the matter, in order to find the means to help the 82 victims of that drug who are still alive in Canada?

Hon. Marc Lalonde (Minister of National Health and Welfare): Mr. Speaker, as early as 1962, the Canadian government, in co-operation with the provinces, was one of the first governments in the world, I think, to develop a joint program of full services for thalidomide victims. This program is available to all thalidomide victims, and all parents of a child who has been affected by this drug may benefit from this program.

Furthermore, officials have recently held a meeting with representatives of the firm responsible for the production of this drug, and I understand that the representatives of this firm are negotiating with the parents of all these children in order to come to a settlement in this matter.
