AMOUNT OF WESTERN CRUDE OIL THAT CAN BE MOVED FROM ONTARIO TO QUEBEC MARKET—EFFECT OF TRANS MOUNTAIN PRODUCTION ON ESTIMATED SHORTFALL

Mr. Peter C. Bawden (Calgary South): Mr. Speaker, my supplementary question is for the Minister of Energy, Mines and Resources. On November 28 the minister told the House that it was his estimate that 40,000 to 60,000 barrels per day of western crude oil could move from [Mr. Latulippe.]

Ontario to the Quebec market. In view of the fact industry people have said in the past week that this is pure fantasy, would the minister say whether it is pure fantasy?

Hon. Donald S. Macdonald (Minister of Energy, Mines and Resources): Mr. Speaker, there is a difference of opinion in this regard between officials of the Department of Transport and my department and of the industry. There is a feeling within government circles that with certain physical changes in the system, plus the kind of direction that could be given by the energy resources allocation board, a higher rate of throughput could be achieved.

Mr. Bawden: Mr. Speaker, if I may use the minister's words, he has said there are some facts upon which reasonable men can differ. Can the minister say whether it is true that the Trans Mountain Pipe Line is now putting through some 50 per cent more volume for eastern markets, the volume having risen from 50,000 barrels a day to 75,000 barrels a day or an amount of 875,000 gallons per day, and will this amount take care of the entire shortfall that he projected some weeks ago?

Mr. Macdonald (Rosedale): Mr. Speaker, I would have to check the hon. member's figure on throughput. The figure with regard to shortfall was a prospective one and it could be, as has been indicated today, even greater if there are certain international complications.
