Member knows, a couple of months ago one of the bidders in this very complex contract bid process, that is open and up front, raised some concerns. As a result, the Government of Canada initiated two independent but internal studies, both of which proved to show no wrong-doing.

The Hon. Member knows as well that a couple of weeks ago I confirmed that there indeed was an RCMP investigation into this matter. I want to report to the House that the Commissioner of the RCMP concluded in a letter dated July 22 that: "The investigation determined that the complaints received were totally unfounded. No evidence of any wrong-doing surfaced throughout the investigation". As a result, we are going to continue with our evaluation and proceed according to plan.

My supplementary for the Minister is this: Could he explain to the House and to the people of this country why Canada continues to give credibility to South Africa, to a racist government, by allowing it to maintain diplomatic relations with Canada?

Right Hon. Joe Clark (Secretary of State for External Affairs): Mr. Speaker, I will repeat in French what I said before, namely that the Liberal Party's position on South Africa, when it was in power, was to accept apartheid. The position of the Progressive Conservative Government was and is to fight energetically against apartheid.

As far as diplomatic relations with South Africa are concerned this is an issue that has been discussed at length here in the House. The Canadian Government's position is clear. The Canadian Government's position is respected by the Blacks in Southern Africa as well as by individuals who are truly concerned about fighting apartheid. It may be that for partisan purposes, the Liberal Party would like to change the position it took as a Government . . . To us, it is a matter of principle. The Canadian Government is showing strong leadership in the fight against apartheid.
