

Scientific instruments and apparatus, including globes, when imported for the use of colleges, and scientific or literary societies.
 Seed for agricultural purposes; specimens illustrative of natural history.
 Steam engines, boilers, propellers, water-wheels and saws, when used in the original construction of steam boats built in this colony, and of mills and factories.
 Sulphuric acid, when used for the manufacture of manures.
 Twines, to be used in manufacturing nets and netting, in this colony.
 Unmanufactured wool.
 Wheat.
 Works of art, namely: Engravings, paintings, statuary, not intended for sale.

Local Distillation.

The following duties shall be raised, levied, and collected on the following articles distilled or brewed in this colony, namely:—

Brandy, not exceeding the strength of proof by Sykes' hydrometer, and so in proportion for any greater strength than the strength of proof, the gallon.....	\$175.
Whiskey, not exceeding the strength of proof by Sykes' hydrometer, and so in proportion for any greater strength than the strength of proof, the gallon.....	1.60
Gin, not exceeding the strength of proof by Sykes' hydrometer, and so in proportion for any greater strength than the strength of proof, the gallon.....	1.45
Rum, not exceeding the strength of proof by Sykes' hydrometer, and so in proportion for any greater strength than the strength of proof, the gallon.....	1.20
Ale, porter, bavarian beer, botanic beer, and all other malt and dextrinous liquors, the gallon.....	0.05

HARBOR MASTER AND HARBOR DUES.

Harbor Master—Staff-commander Robinson, R. N.

Harbor Dues—The following amounts, as harbor dues, shall be paid by vessels arriving at the port of St. John's at the time of their being entered at the Custom-house, except ships of war and vessels engaged in the coasting trade and fishing, viz:

Every vessel of sixty tons and upwards, and not more than one hundred tons, \$2.

Every vessel of more than one hundred tons, and not more than two hundred tons, \$3.

Every vessel of more than two hundred tons, and not more than three hundred tons, \$4.

Every vessel of more than three hundred tons, and not more than four hundred tons, \$5.

Every vessel of more than four hundred tons, \$6.

Provided: That no vessel shall be compelled to pay harbor dues more than once in every half year, viz: Once between the first day of January and thirtieth day of June, and once between the thirtieth day of June and first day of January.
