It would be of great help to the Chair if it could be discussed, either in the House or in the committee. The point is well taken for another occasion.

I do now leave the chair for the House to resolve itself into committee of the whole.

INCOME TAX ACT

MEASURE TO AMEND

The House resumed, from Thursday, December 1, consideration in committee of Bill C-11, to amend the statute law relating to income tax and to provide other authority for the raising of funds—Mr. Chrétien—Mr. Laniel in the chair.

The Chairman: When the committee rose at its last sitting an amendment to Clause 6, presented by the hon. member for St. John's West, was under consideration. Shall the amendment carry?

Some hon. Members: Question.

Mr. Stevens: Before we proceed to the debate on the amendment brought in by my colleague, I wonder if the committee would consent to the Minister of Finance tabling further amendments which he is proposing to make to this bill. Eight of these amendments were offered to us on a private basis on Friday. The minister has added a new one today. You will recall, Mr. Chairman, that a week ago today the minister tabled ten or 12 amendments, and they became part of the record of the proceedings of this House. I think it would be

very helpful if we could have these new amendments also tabled by the minister, if there is consent.
