NOVA SCOTIA SPEAKS.

A Sweeping Liberal Victory Throughout the Whole Province.

Fourteen Solid Counties—A Waterloo for the Tories.

Wednesday's Despatches.

The provincial elections were held in Nova Scotia yesterday, and resulted in an overwhelming victory for the Liberals. Repeal from confederation and reciprocity with the United States were the principal issues at stake, and resulted in the return of 25 government supporters, 4 independents and 9 opposition.

The Liberal Phalanx.—The following counties have gone liberal:—60 majority. Lunenburg, 40. Queens, not stated. Yarmouth, 1,000. Shelburne, 200. Digby, 300. Antigonish, 400. Guysboro, 400. Inverness, 200. Victoria, 200. Hants, 200. Richmond, 200.

The counties of Cumberland and Kings returned a member of each party. Antigonish and Colchester, constituencies of the cabinet ministers Thompson and McLean, went liberal by a very large majority.

Attorney General Longley and Munro are defeated in Annapolis by small majorities.

The Liberals celebrated the victory at Halifax last night by a routing meeting on the steps of the province building. Enthusiastic speeches were made by Premier Fielding, Jones and Robie.

TO-DAY'S NEWS.—Attorney General Longley Elected—Liberals Retain.

HALIFAX, June 16.—The victory for repeal yesterday was more crushing than was realized last night. Mr. Fielding's majority in Halifax county rolled up to 1,000. Attorney general Longley has carried his election and that of his colleagues in Annapolis by a small majority. This insures the return of 25 members of the liberal party, and 4 members of the opposition, and leaves only seven Tories.

The Tory ticket was elected in only one county, that of Cape Breton, where their majority was 400. The Liberals claim that Tory success there was due to the promise of the dominion government to build a trans Atlantic railway line through Cape Breton, and to the strength of the coal mining interests there. The real strength of the movement for separating Cape Breton from Nova Scotia, erecting that island into a separate province of Canada, is shown in the fact that four out of eight Cape Breton Tories are pledged to repeal for Nova Scotia from Canada being the two Cape Breton Tory members. The other five Tories come from Pictou, which returns two Tories and one repealer, Cumberland, Richmond and Kings. Leaving these divided counties out of the calculation there is a popular vote of 5,500 votes in the thirteen counties returning the entire repeal ticket. It is the largest vote on record. There can be no mistaking the meaning of the result either as regards provincial or dominion politics.

SPORTING NOTES.—Horse Racing at Moncton.

Two important match races took place in the Driving Park, Moncton, on Tuesday. The first event was a trot, one mile long, three furlongs, the entries being three Doncaster horses—H. R. Emerson's Gladstone, J. H. Rickman's Vick, Edgar Wilson's Ginger, and one Moncton horse, Alameda. The second event was a sweepstakes of \$100, the entries being: Minnie Warren, owned by J. N. Wilbur of Moncton, and the Doncaster horse Ouida, owned by George H. Wallace, and Donbaid, owned by W. Lawrence. Minnie Warren won in two straight heats.

New York, June 15.—In the yacht race today the "Pretoria" was first in 4.40 p.m.; the "Atlantic" second at 4.40 p.m., and the "Pretoria" third at 4.53 p.m. The "Pretoria" allows the "Atlantic" 30 seconds and the "Pretoria" 2 minutes 12 seconds. Light winds preclude a thorough judgment of the yacht.

Edward Jack's Visit to the Border.—Mr. E. Jack, who has just returned from the head waters of the St. Croix and Machias rivers, in the State of Maine, reports that the property of the St. Croix and Machias rivers, where visible, especially near the border, and he reports his party as having seen numbers of them. FIFTY LIVES LOST.

In the Great Fire in Vancouver, B. C.—Three Thousand Homeless People.

The city of Vancouver, B. C., was obliterated by fire on Sunday last. Only four houses remain out of 500.

The Western half a million dollars, insurance one hundred and fifty thousand dollars. Fifty lives are known to be lost; ten bodies have been recovered. 3,000 people are homeless without provision.

The property saved is insignificant. A clean sweep defines the situation. A thousand men are to work clearing up for the P. Railway. Twenty contracts for rebuilding are already let. Only three out of the ten bodies have been identified.

Many men are ruined, but are determined to start in again on the old location. The property loss will fall directly upon the pioneer element of the new town. Hundreds of people are camped out. New Westminster people—rival sister city—are especially open-handed and liberal. Prompt aid from the Canadian Pacific railway is expected.

Heroes and hardships characterized the whole dreadful affair. Families were compelled to abandon their homes without a moment's warning and flee for their lives. Those in search of valuables were compelled to rush through the flames and smoke to perish. The whole city was ablaze and the panic stricken population sought refuge from the horrible holocaust.

For people have more than the clothes they stand in. All the frame buildings in town will be rapidly re-built mostly of brick. Contractors for a large hotel and other extensive buildings, representing half a million dollars, were let just before the fire.

Toronto, June 16.—There has been no further news from British Columbia regarding the Vancouver fire. Mayor Howland to-day deposited on behalf of the city \$10,000 with the Bank of British North America for the aid of the sufferers, and wired Mayor McLean, Vancouver, that that amount should be his order was at that bank's branch in New Westminster.

Private subscriptions already have been received by the mayor amounting to over \$250.

Tax Collecting—The Installment Plan.—The assessment roll is in the hands of the city treasurer and a five per cent discount is allowed to all who pay their taxes previous to the 15th of July. Any person wishing to pay his taxes by installment can do so by notifying the city treasurer. This installment system was adopted by the city council at its May meeting and by it any person can pay his taxes by installment after the following manner—one-half of the whole tax must be paid within the first sixty days and the balance in the next 90 days; and after the expiration of the 90 days, an extension will be issued for any balance that remains unpaid. The parties claiming this installment plan are not allowed any discount, but no cost can be incurred until after the expiration of the 90 days.

The Commercial Hotel.—The commercial hotel, on York street, has been purchased by Major Staples, of St. John, N. B., the tenant being Major Staples. Major Staples has also bought out the hotel furniture, and assumes the management of the hotel to-day. The stand, for the hotel is being erected on the site of the old hotel, and with the number of improvements the new and enterprising proprietor intends that the hotel will be one of the best in the city. Major Staples, who is the owner and proprietor of the hotel since his father's death, intends to remove to his new home in the city.
